Brief History of Board: The Arts Council of Alachua County was established by Ordinance 18-07 on February 13, 2018 and Resolution 18-17 on February 13, 2018.

Responsibilities and Duties:

- 1. Serve as a resource for local artists and art agencies, including all municipalities, throughout Alachua County.
- 2. Prepare applications for state and federal grants and re-grant eligible grants to local artists and local arts agencies.
- 3. Prepare applications for eligible state and federal grants to provide enhanced resources for local artists and local arts agencies.
- 4. Educate and advocate at the state and federal level on issues affecting the arts.
- 5. Promote and facilitate the inclusion of art into an established process that connects artists, partners and communities for the purpose of enhancing the vitality of the County.
- 6. Responsible for oversight, administration and promotion of Art Tag proceeds and Local Arts Agency dedicated funding.
- 7. Develop an inclusive strategic plan for county-wide arts and cultural assets that is reviewed and updated annually.
- 8. Report annually, or as necessary, to the Alachua County Board of County Commissioners on the goals and accomplishments of the Advisory Committee.

Accomplishments:

- Held meetings on Oct. 3, Nov. 7, and Dec. 5, 2022 and Feb. 6, Mar. 6, Apr. 3, Jun. 5, Aug. 7, and Sep. 11.
- Completed the Call to Artists for our Fire Stations 21 and 80, the Court Services Building (on hold) and Pleasant Street Mosaic.
- Unveiled the West Lawn Sankofa in honor of Dr. Patricia Hilliard-Nunn
- Held the Second Annual Artists Conference at Cuscowilla Nature & Retreat Center in May.
- Completed Art Tag Grant applications and awards.
- Provided input to Visit Gainesville, Alachua County, FL for the Arts & Economic Prosperity 6 Study.
- Reviewed Jack Durrance Art loans from Drew Marotte, Tony Bevilacqua, and Patrice Boyes.
