4.1 Community Health Worker Program Update

5. New Business

5.1 Discussion of CHOICES funding

Alex Corona presented the CHOICES budget and future options

Q&A:

- Q: The vaccine funds are they being used in addition to DOH billing or in lieu of?
- A: The vaccine reimbursement is just per vaccine given, it does not take into account costs or insurance
- Q: Is the vaccine fund from the general fund?
- A: It was pulled from the general fund and put into a trust, it is not surtax money.
- Q: Do the trusts generate any dividend or interest? What about the general fund?
- A: The trust does generate interest that can be used by the programs, the general fund does not accrue interest that is usable by the program
- Q: Would general funds have to go through an RFA/RFP process the same as the trust?
- A: Yes, the programs applying for the money would still need to go through the competitive RFA process
- Q: Can we merge all the trusts and are there any drawbacks?

- A: Yes, it is possible, only drawback would be more difficult reporting
- Q: If we wanted to run one large RFA program, would it be difficult to separate out the healthcare and other funds?
- A: It is possible, it could be broken into divisions
- Q: If the CHOICES and CAPP go into the general fund, is there more competition for the funds?
- A: It is a possibility if it stays in the general fund, but anyone applying must still meet the requirement criteria of the RFA being funded

5.2 Program Updates

- Frank: Expect Bills to come out of legislative committee in the next month or so, hearings will not start until January
- Tina: Celebrating 50th anniversary of ACORN this year
- Aaron: Community Outreach Mobile grant for maternal health was announced
- Erica: Last month was highest ever after-hours clinic attendance.
 25% primary care, 12% for WIC, 10% family planning, 50% communicable diseases and the rest are vaccine records etc.
 WeCare Dental clinic increased from 10 to 13 seats
- Catherine: Seeing 110 people a week for new food pantry through Bread of the Mighty. New Saving Smiles clinics on Saturdays once a month
- Jaye: Going into new CAPP cycle, The Arc of Alachua County has secured a provider
