Assistant County Manager Gina Peebles presented comments regarding the upcoming summer day camp at Cuscowilla. She advised that this year the School Board is not able to provide busing for the children to get to camp and back. Chief of Teaching and Learning Jennifer Wise, Director of Data Analytics, Evaluation, and Accountability Taylor Gilfillan, and Director of Curriculum Kevin Berry presented the above item.

Commissioner Wheeler, Member Dr. Rockwell, Member Abbitt, Commissioner Cornell, Chair Prizzia, Member McGraw, Commissioner Cornell, School Board Chair Certain, Member McGraw, Dr. Rockwell, Commissioner Alford, and Commissioner Wheeler presented comments.

Commissioner Cornell moved to direct staff to work with School Board of Alachua County, the Children Trust of Alachua County, University of Florida and other stakeholders to develop and fund a Comprehensive Plan for literacy in Alachua County and bring back recommendations to this Board. This Comprehensive Plan will be led by the School Board of Alachua County. The motion carried 4-0 with Commissioner Chestnut absent.

Member Rockwell moved to direct the Superintendent and staff to work with Alachua County Board of County Commissioners, the Children's Trust of Alachua County, and other relevant stakeholders to develop a Comprehensive Literacy Program and lead implementation of that program. Chief of Teaching and Learning Jennifer Wise presented the above item.

Ms. Wise discussed that there are 90% scholarships available for those on free lunch and 50% scholarships available for those on reduced lunch. She advised the Board

Chair Prizzia, Commissioner Alford, Commissioner Cornell, and School Board Finance Director Alex Rella presented comments.

Commissioner Cornell moved to direct staff to work with School Board staff and bring back transportation solutions for the County summer day camp program at Cuscowilla.

2. Broadband and Technological Access 23-0663

Instructional Technology Chief Officer Uma Shankar and Assistant County Manager Crosby presented the above item.

Mr. Shankar informed the Board that Wi-Fi is available in every classroom in the County. He further stated that over 7,000 laptops with 4G data like a cell phone so that students have access to the internet at home as well. The school buses have also been equipped to provide Wi-Fi to students. The devices are owned by the School Board. The difficulty will be to continue the connectivity once the grant funding ends.

Mr. Crosby advised the Board that the County has set aside \$15,000,000 to provide rural broadband throughout the County. Currently the committee is trying to establish where the needs are. There are several grants available to extend service. The Board tomorrow will see two letters of support for grants one for AT&T for 6,600 homes in the Archer and Hawthorne areas. The second is for IBT for 2,500 homes in High Springs and Hawthorne area. The major issue is the take rate which is the percentage of paying customers in an area of service. Companies generally need about a 60% rate to be profitable. As more providers become available achieving the necessary take rate may be difficult. The County is also trying to get citizens to provide information on a survey and so far only about 10% have responded to the survey.

School Board Chair Certain inquired if it was possible to push a message regarding the survey to the laptops distributed to school students when they need to be refreshed in an effort to increase the response to the County's efforts.

Chair Prizzia, Commissioner Alford, Commissioner Cornell, Commissioner Alford, Member Dr. Rockwell and Chair Prizzia presented comments.

Member Dr. Rockwell moved to direct staff to collect data on who lacks availability to broadband and who has an affordability issue with connecting to available broadband and provide that data to the County. The motion carried 5-0.
