Prior Board Motions:

August 27, 2019, Board approved Florida Department of Transportation (FDOT) LAP Agreement for oversight of the design of the intersection at Newberry Lane and CR 235. Item 19-0001.

September 16, 2021/October 26, 2021, Board approved FDOT LAP Agreement for construction and CEI project management for intersection improvements at Newberry Lane and CR 235. Item 21-0897.

Fiscal Note:

Approve budget amendment to move funds from two projects: \$7,238 from NW 43rd and NW 16th Light Signal (account 341.79.7910.541.63.01) and \$15,218 from SW 24th Ave Sidewalk (350.79.7910.541.63.01) for a total of \$22,456 to supplement the \$189,296 in LAP funding from FDOT in account 329.79.7910.541.63.01.

Background:

The CR 235 at Newberry Lane project is an intersection safety improvement by adding additional

flashing beacons and warning signs to create an intersection conflict warning system. Staff applied for a Highway Safety Grant for the intersection in 2018.

BID 23-994 Intersection Improvements at CR 235 and Newberry Lane – Project 9197909 – LAP - Rebid was released on January 4, 2023. The deadline for receipt of BID 23-994 Intersection Improvements at CR 235 and Newberry Lane – Project 9197909 – LAP - Rebid was March 8, 2023, one (1) vendor responded.]
