Created Gainesville opened a 6-bed 18-month residential program specifically designed for the unique needs of survivors of sex trafficking and sexual exploitation in March of 2022. This program includes the following phases, which are meant to not only offer the opportunity for needed healing and restoration from one of the worst forms of victimization and exploitation of our times, but is also meant to empower and instill skills and tools that will support a future of sustainability, safety, and confidence. These 4 phases include: stabilization, rehabilitation, development, and empowerment.

The model of care that has been developed for this program was with the input of local survivors who for the past 10 years, through our efforts of outreach and building trust and community, have identified what the greatest needs and vulnerabilities for revictimization are in our community, and what obstacles have prevented breaking cycles of trafficking, abuse, addiction, incarceration, and homelessness that are common for survivors the longer they have been impacted by the traumas of sex trafficking. Created Gainesville has also spent the last decade learning being in mentorship with other service providers around the country who have pioneered services like the ones provided locally.

Created Gainesville collaborates with law enforcement and other service providers and is also a member of the National Trafficking Sheltered Alliance, which is a nationally recognized and respected organization that provides credentialing, on-going education, and research for best practices for the field of anti-human trafficking work.

Upon entering the Created Gainesville Residential Program, participants are paired with a case manager who is on staff and who consistently meets with clients for goal setting, problem solving, processing, and accountability. Created Gainesville's case managers also ensure that each participant is paired with a partnering licensed mental health counselor, primary care physician, gym access, and as needed psychiatrist and/or dentist. Case managers also ensure that each participant has opportunities to grow skills, experiences, and community support.

Participants have the opportunity for continued education, job skill training, and life skills development for the purposes of equipping every participant for earning a wage that is sustainable, in an environment that is empowering and satisfying.

Prior to Created Gainesville opening their Residential Program last year, survivors had one of 2 options; either be referred to a residential program out of town/state with a possible wait time of 2 weeks-6 months, or participate in our non-residential program called Created Care. A couple of realities for survivors of sex trafficking is that wait times are not a luxury they have when escaping from a trafficking situation AND not every survivor is going to thrive in a non-residential program. In order for non-residential programs to be effective for what survivors of sex trafficking need, a survivor needs to have both safe housing of their own and have already completed some level of rehabilitation in the recent past. These two factors are rare for the referrals received by Created Gainesville. Non-residential care has tremendous value as aftercare following a Residential Program and when there is stability already present, but it cannot replace the need for a safe affordable place to call home while doing the initial hard and necessary work of recovering from complex trauma from sex trafficking.

The addition of the Created Gainesville Residential Program means that more survivors have access to the life-changing and at times life-saving support and comprehensive care it requires for escaping the cycles mentioned above, and reclaiming a safe life that is about more than surviving, but involves thriving and flourishing. While participants work through the phases of this Residential Program, all services are free of charge. Once participants are in the latter 2 phases of the program and are working, each sets up a bank account and works towards financial goals that will support a sustainable transition to independent living. This includes saving for a vehicle and for future housing needs. Every participant receives coaching on financial literacy, creating and following a livable budget, and preparing for life's unexpected expenses that can easily derail if not prepared.

Created Gainesville aims to ensure that every participant leaves the program with more tools and opportunities to work with than when they first entered the program. Opportunities equal empowerment and empowerment changes the narrative of what is possible.

If awarded, the funds would immediately go into the above 2 line items to keep the Residential Program running and serving the maximum number of residents possible with excellence by providing safe, affordable, and purposeful housing to survivors of sex trafficking and sexual exploitation. Created Gainesville's Residential Program is the only one of its kind in Gainesville and in North Central Florida. With the global pandemic, economic crisis for some of our donors, and the challenges that both of these factors have presented for Created Gainesville, this funding is very needed and essential to our ongoing impact on the lives of those we serve not only through Residential Care, but also through Created Gainesville's consultant and referral management services, non-residential care, outreach efforts, and Youth Prevention for local middle and high school students.

What we know is that in the United States as a whole, we only have enough safe beds to serve 10% of victims of human trafficking. In addition, Florida is ranked 3rd in the nation for reported cases of human trafficking. The large majority of these cases involve sex trafficking (approximately 79%). The average range of first trafficking experience for those served at Created Gainesville (which also reflects national data) is between 11-17 years of age, with most victims not initially identifying as a victim due to grooming tactics, fear,
