Description:

Change Order 2 to Purchase Order 2022-1660 to Bliss Products & Services, in the amount of \$17,360.00, at Santa Fe Lake Park for Parks & Open Space. Changes are for additional sitework components to support work for the installation of a new precast concrete restroom building adjacent to the playground. This includes removal of two (2) trees, installation of tree barricades, extension of sidewalk, additional fill dirt, and overseeding of disturbed areas. The revised purchase order total is \$58,610.00.

Background:

Santa Fe Lake Park, now known as the Jill McGuire Santa Fe Lake Park, is a county park located at 24500 NE SR 26, Melrose, FL 32666 and includes a boat ramp with access to the 5,850-acre lake which is located entirely in Alachua County.

Alachua County Parks & Open Space has recently installed a play area, and the new restroom will soon be constructed close to the play area. A nutrient reducing septic system for the new restroom was installed in mid-June and the restroom over it should be installed by August, along with these changes.
