SECOND AMENDMENT TO AGREEMENT BETWEEN ALACHUA COUNTY AND GLOBAL TIRE RECYCLING OF SUMTER COUNTY, INC., FOR ANNUAL PROCESSING OF WASTE TIRES, NO. 12082

THIS SECOND AMENDMENT ("Amendment") is made by and between Alachua County, Florida, a political subdivision and charter county of the State of Florida, by and through its Board of County Commissioners (the "County") and GLOBAL TIRE RECYCLING OF SUMTER COUNTY, INC., a Florida for Profit Corporation, which is authorized to do business in the State of Florida ("Contractor"), who are collectively referred to as the "Parties".

WITNESSETH:

WHEREAS, the Parties previously entered into a Contractual Services Agreement, dated December 14, 2021, for Annual Processing of Waste Tires, identified by No. 12082 (the "Agreement"); and

WHEREAS, the Parties previously entered into the First Amendment to the Agreement, dated August 11, 2022, through which the Agreements term was extended through September 30, 2024 (the "First Amendment); and

WHEREAS, the County has experienced an unexpectedly higher use of the services provided by the Contractor which necessitates an increase in the Agreements annual Not to Exceed amount; and

WHEREAS, the Parties desires to amend the Agreement to increase the annual Not to Exceed amount and to do as otherwise provided herein.

NOW, THEREFORE, the County and Contractor agree to amend the Agreement as follows:

- A. <u>Amendment</u>. Section #4, of the Agreement titled "Method of Payment", sub-section 4.1 is amended in its entirety to read as follows:
 - 4.1. The County shall pay the Contractor in accordance with the Fee Schedule attached hereto as Exhibit 2, up to a total amount that shall not exceed One Hundred Seventy Five Thousand Dollars and No Cents (\$175,000.00) per fiscal year. For the purposes of this Agreement, a fiscal year commences on October 1st and ends on September 30th.
- B. Effective Date. This Amendment shall be effective upon execution by both Parties.
- C. <u>Original Agreement</u>. Unless expressly amended herein, all other terms and provisions of the original Agreement between the Parties, including any prior amendments to the Agreement, shall be and remain in full force and effect. In the event any of the prior amendments to the Agreement conflict with this Amendment, the provisions of this Amendment shall prevail.
