1. Policy Discussion on Parameters of the Pavement Management Program 23-0509  
**Recommended Action:** Provide direction to staff on Parameters of the Pavement Management Program  
**Fiscal Consideration:** Funding Sources include General Fund Transfer, Infrastructure Surtax (70% of  $\frac{1}{2}$ ), Grants, 5 Cent Local Option Gas Tax (ELM Nickel), Impact Fees, and Multi Modal Transportation  
**Strategic Guide:** All Other Mandatory and Discretionary Services

Public Works Director Ramone Gavarrete and Consultant Aaron Gerber presented the above item.

Mr. Gavarrete stated that there are currently 1,805 roads in the system. Currently 1,543 of the roads are considered residential roads. He advised that the County has made progress in slowing down the deterioration of the road system. The current ranking of road projects was presented to the Board.

The Board requested the staff to run two scenarios in the system using the 40% base scenario with residential and the blue bubbles. Scenario one is moving the funding around to maintain the level of the collector roads and optimize the benefit to residential streets. The second scenario is to run the optimization with up to \$1,000,000.00 in new funding a year to see the results for the Board to consider during the budget process. The floor level for the collector roads should be 52.5 to 53.

The Board discussed the need for setting weight limits on roads and the placement of the signs.

Commissioner Cornell, Chair Prizzia, Commissioner Alford, Dr. Houchen, Commissioner Cornell, Transportation Planning Manager Chris Dawson, Chair Prizzia, Commissioner Cornell, Commissioner Alford, and County Manager Lieberman presented comments.

The Board agreed to have the next discussion of the pavement management system on April 4, 2023 at 1:30 p.m.
