2nd Commissioner Wheeler

Commissioner Cornell, Deputy County Manager Carl Smart, Chair Prizzia, County Manager Lieberman and Sheriff Watson presented comments.

The motion carried 5-0.

Items for Discussion

1. Alachua County Jail Telephone System 23-0499

Recommended Action: Consider Options 1-4

Fiscal Consideration: Option 1 \$580k loss per year as a budget shortfall must be determined not including any one time capital cost for telephone systems or additional staff.

Option 2 \$375k loss per year as a budget shortfall must be determined not including any one time capital cost for telephone systems or additional staff.

Option 3 \$75k loss per year as a budget shortfall must be determined.

Option 4 \$1,675,000 loss per year as a budget shortfall must be determined.

Significant capital costs for telephone systems or additional staff.

Major Dorian Keith Director of the jail gave a presentation on inmate phones and reviewed the Florida Model Jail Standards (FMJS) which must be upheld to ensure the constitutional Rights of those incarcerated.

FMJS requires a certain amount of space in Housing units.

FMJS required space

Chapter 16 of FMJS 2023 – Physical Plant states the following:

The following housing standards apply to all facilities:

Specified unit of Floor Space:

- >Single cells shall contain a minimum of 63 square feet of floor space
- >Multiple occupancy cells shall contain a minimum of 40 square feet of floor space per inmate in the sleeping area
- Dormitory Housing Units shall contain a minimum of 75 square feet of floor space per inmate, including both sleeping and dayroom areas.
- > Dayrooms shall contain a minimum of 35 square feet per inmate for all cell areas, except Disciplinary and Administrative Confinement.

County presented - Option 1 — Seven free 15 - minute calls per week for each inmate (1 free call per day)

- Based on an average of 80 inmates per Housing Unit
- 80 x 15 minutes = 1200 minutes
- 1200 minutes x 7 = 8,400 minutes additional per week = 140 hours

This option is feasible with the addition of (to accommodate the entire facility) 9 FTE's, 6 Phone Quads and 9 single phones.

This would require modifications to infrastructure

County presented - Option 2 — Five free 15 - minute calls per inmate per week with a maximum of one call per day

- Based on an average of 80 inmates per Housing Unit
- (15 x 5) 75 free minutes per inmate, per week
- 80 x 75 = 6,000 (100 hours of additional phone usage per week) minutes per Housing Unit

This option is feasible with the addition of (to accommodate the entire facility) 7 FTE's, 6 Phone Quads and 6 single phones. This is less of a risk compared to Option 1 because you have two days of normal phone usage or you have the ability to spread the (5) calls over a 7 day period

Modifications to infrastructure would be required

County presented - Option 3 – Two free 15minute calls per inmate per week with a maximum of one per day

- Based on an average of 80 inmates per Housing Unit
- 80 x 15 minutes = 1200 minutes
- 1200 minutes x 2 = 2400 minutes = 40 hours

This option is feasible with the addition of (to accommodate the entire facility)(5) FTE's, 3 Phone Quads and 4 single phones.

Modification to Infrastructure would be required

County presented - Option 4 – Unlimited free calls per inmate per week

• Requires a significant increase in staffing and infrastructure modifications. We would have to base the number of FTE's and the number of additional phones by comparing to the other options and reviewing the amount of actual usage. Then it would be a trial and modify as time progresses.

ASO Major Keith stated that in order to achieve the goal of unlimited free phone calls for all inmates the following would need to happen:

- To achieve the goal -
- A minimum of (2) Quads would need to be added to the larger Housing Units.
- A minimum of (2) Single Wall Phones would need to be added to the smaller Housing Units.
- Due to the lack of space, Construction would have to occur to add additional floor space for the addition of phones.

Major Lance Yeager with ASO department of support services gave a presentation reviewing telephone calls and video visits for inmates.

Vice Chair Alford, Major Lance Yeager (ASO), Securus Advisory Account Manager Paul Cappiello, Vice Chair Alford, Major Lance Yeager (ASO), Sheriff Watson, Vice Chair Alford, Chair Prizzia, Sheriff Watson, Chair Prizzia, Commissioner Cornell, and Vice Chair Alford all presented comments.

Commissioner Alford moved the following:

- 1. Direct the County Manager work with the Sheriff to provide Option 2 all inmates 5 free 15 minute phone call per day for a 90 day trial and make the necessary contractual amendments for the trial within 60 days. (Option 2 as a trial with a Goal of Option 4)
- 2. Direct the County Manager or her designee to renegotiate the service rate from a permanent charge to a per line charge with Securus Technologies. If Securus does not agree with that negotiation then offer the contract to the lowest service option to provide a flat per month active per line fee.
- 3. As equipment is available to increase the amount of time given per inmate with a goal of unlimited calls.
- 4. Continue to explore the use of tablets including the free tablets available by Federal Grant.
- 5. That the Board takes the necessary funds required from the Reserves.

2nd Commissioner Chestnut

Commissioner Cornell moved the substitute motion to approve Option 2 and to direct staff to transfer operational control of the phone contract to the Sheriff and begin implementing this direction as soon as possible but no later than October 1, 2023. Also request the Sheriff explore the use of tablets and bring back recommendations prior to the start of the next fiscal year which is October 1, 2023.

Chair Prizzia passed the gavel to Vice Chair Alford in order to make a motion.

Commissioner Cornell withdrew his motion.

Commissioner Prizzia moved the following substitute motion:

- 1. To eliminate the subsidy of the County portion of the phone calls immediately/as soon as possible. (This will result in the cost per call being reduced by 9 cents cheaper.)
- 2. Work with the Sheriff to negotiate a plan to implement free phone calls by October 1, 2023. (A no cost option. This means without enhancing the infrastructure for the system.)
- 3. Exercise the option to terminate the contract with Securus and work with the Sheriff to write a Request for Proposals (RFP) as soon as possible for phones to be free at the Jail.
- 4. Staff to make necessary amendments with Securus to implement this plan. The funding source will be the Sheriff Carry Forward Funds or vacancy funds.
