NOTICE IS HEREBY GIVEN that the Board of County Commissioners of Alachua County, Florida, will consider the adoption of an ordinance at its meeting to be held on September 12, 2023, at 11:30a.m., or as soon thereafter as the matter may be heard. The hearing will be held at the Alachua County Administration Building, 12 SE 1st Street, Second Floor, Jack Durran Auditorium, Gainesville, Florida 32601. Said ordinance being titled:

AN ORDINANCE OF THE BOARD OF COUNTY COMMISSIONERS OF ALACHUA COUNTY, FLORIDA; REPEALING ALACHUA COUNTY CODE, PART II, TITLE 6, CHAPTER 65 ENTITLED 'RESIDENTIAL RENTAL UNIT PERMITS'; AMENDING THE ALACHUA COUNTY FEE SCHEDULE TO REMOVE A PERMIT FEE; PROVIDING FOR MODIFICATION; PROVIDING FOR INCLUSION IN THE CODE; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.
