RESOLUTION OF THE **BOARD** OF COUNTY **ALACHUA** COMMISSIONERS OF COUNTY, FLORIDA, RELATING TO ITS BUDGET FOR THE 2023-2024 FISCAL YEAR: REVISING THE ESTIMATE OF RECEIPTS AND OF BALANCES TO BE BROUGHT FORWARD; ADOPTING A FINAL ALACHUA COUNTY MUNICIPAL SERVICE TAXING UNIT- LAW ENFORCEMENT BUDGET; PROVIDING AN EFFECTIVE DATE.

WHEREAS, on June 13, 2023, the County Manager, as the Alachua County Budget Officer, presented a balanced budget for further consideration by the Board of County Commissioners in accordance with applicable law; and,

WHEREAS, said budget contained estimates of receipts and of balances brought forward as part of the budget presentation; and,

WHEREAS, the Board of County Commissioners adopted Resolution 2023-70 on September 12, 2023, revising the Budget Officer's estimates of receipts and of balances to be brought forward; and,

WHEREAS, the Board of County Commissioners wishes to further revise the estimates of receipts and of balances to be brought forward based on the most current information available as of the date of this resolution; and,

WHEREAS, the Board of County Commissioners of Alachua County, Florida, has complied with all the conditions precedent to the adoption of a final Municipal Service Taxing Unit-Law Enforcement budget; and,

WHEREAS, the Board has this date adopted a resolution adopting the final millage to fund a final Municipal Service Taxing Unit-Law Enforcement budget;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ALACHUA COUNTY, FLORIDA:

- 1. In accordance with the requirements of Section 129.03, Florida Statutes, the estimates of receipts and balances to be brought forward are revised as set out in the document entitled "FY 2023-2024 Final Budget."
- 2. The final Alachua County Municipal Service Taxing Unit-Law Enforcement budget contained in the document entitled "FY 2023-2024 Final Budget" is hereby adopted as adjusted by motion.
 - 3. This resolution shall take effect immediately upon its adoption.
