## Background:

Local Workforce Development Board 9 (LWDB 9) oversees career center operations, provided by CareerSource North Central Florida (CSNCFL), in Alachua and Bradford Counties and receives funding by State program year (July 1-June 30) through formula, discretionary and dedicated grant purposes. LWDB9 received new funding for Supplemental Nutrition Assistance Program (SNAP) in the amount of \$40,000 for the period of October 1, 2022 to September 30, 2023, the Disabled Veterans Program (DVOP) in the amount of \$10,256 for the period of October 1, 2022 to December 31, 2024, the Local Veterans Program (LVER) in the amount of \$5,810 for the period of October 1, 2022 to December 31, 2024, for the WIOA Youth Program in the amount of \$958,994 for the period of April 1, 2023 to June 30, 2025, for the WIOA Rural Initiatives in the amount of \$62,500 for the period of July 1. 2023 to June 30, 2024, for the Welfare Transition Program (WTP) in the amount of \$165,712 for the period of July 1, 2023 to November 30, 2023, for the WIOA Adult Program in the amount of \$437,659 for the period of July 1, 2023 to June 30, 2025, for the WIOA Rapid Response Program in the amount of \$50,000 for the period of July 1, 2023 to June 30, 2024, for the WIOA Dislocated Workers Program in the amount of \$473,216 for the period of July 1, 2023 to June 30, 2025, for the Wagner Peyser Program (WP) in the amount of \$172,125, for the Wagner Peyser Hope Florida Program in the amount of \$55,781.16 for the period of July 1, 2023 to June 30, 2025, for the WP Apprenticeship Navigator Program in the amount of \$62,500 for the period of July 1, 2023 to September 30, 2024 and the WIOA Hope Florida Program in the amount of \$79,686.98 for the period of July 1, 2023 to June 30, 2025. LWDB 9 received a non-federal pass-thru award from Ares Charitable Foundation for the Quality Green Jobs Regional Challenge in the amount of \$10,000 for the period of July 1, 2023 to December 31, 2023.
