

Introduction

Alachua County Syringe Exchange Program (SEP) Assessment and Feasibility Purpose and Process

In response to the Alachua County Board of County Commissioners' Solicitation of Interest (Ordinance No. 2020-20 Needle Exchange Program) issued in May 2021, WellFlorida Council proposed a comprehensive readiness and needs assessment as part of the planning process for a SEP in Alachua County. While WellFlorida Council proposed to take the leadership role, the assessment, feasibility discussions, and planning work will be a collaborative effort. Among the strategies employed are the engagement of a multi-disciplinary and diverse Advisory Council and collecting input from persons who would potentially use and/or benefit from the availability of a SEP in Alachua County.

SEP Intercept Survey Methodology

Process

WellFlorida Council developed an intercept survey with input from harm reduction advocates with Out of Harm's Reach, a Gainesville-based non-profit agency. The survey was designed to be administered face-to-face by trained individuals to Alachua County residents aged 18 years and older who are or were injection drug users in the past 90 days. The survey instrument included 21 questions and seven (7) demographic items and was tested for readability (i.e., Flesch Kincaid grade level score of 6.8 was achieved). Intercept survey participants were not required to give their full names nor addresses and no identifying information was attached to any survey documentation. The information gathered from the intercept interviews was entered by the interviewers into a Qualtrics® web-based surveying platform to secure and analyze the information.

A convenience sampling approach was utilized for conducting the intercept surveys, i.e., respondents were selected based on eligibility, accessibility and willingness to participate. Intercept survey participants were identified, contacted, and surveyed by Out of Harm's Reach harm reduction advocates who were trained on this survey technique in advance. Surveying was conducted from October 1 to October 31, 2021. A second collection of intercept surveys occurred from XX – January 31, 2022 through partners at UF Mobile Clinic where participants were identified, contacted, and surveyed by UF Mobile Clinic volunteers.

Survey Limitations

Using the convenience sampling method to collect input for a program feasibility study and needs assessment process has its advantages, disadvantages and limitations. Information collected using this method can yield rich qualitative data for assessment and planning in a cost-efficient manner. Data are available relatively quickly to match the pace of an assessment and are useful to signal the beginning of changes or shifts in attitudes and behaviors. Among the disadvantages of convenience sampling are the potential for bias in data collection and sampling errors that could introduce inaccuracies. The convenience sampling method has its limitations. Survey participants were preselected which may have introduced selection bias. As such the results are not generalizable to the

entire population. Even with these limitations, valuable insights, perspectives, and opinions were generated and will contribute to gauging the feasibility of establishing a SEP in Alachua County.

Survey Results

At the close of the two survey collection periods, 30 intercept surveys had been conducted. The general demographic factors collected on respondents who completed surveys are presented in Table 1. Tabulated results from survey items are presented in Tables 2 – 23 and Figures 1 – 3.

Participant Profile

The table below shows the demographics of those who participated in the intercept survey. All of the participants were Alachua County adult residents who had injected drugs in the past 90 days. More than two thirds (73.3 percent) were under the age of 40 years. The majority of intercept survey participants were male (76.7 percent), were non-Hispanic (86.7 percent), and were White (76.7 percent). Ten (10.0) percent identified as transgender. Less than a quarter (20 percent) of participants reported having stable housing; 73.3 percent said they were homeless with another nearly 7 (6.7) percent in unstable or temporary housing.



FIGURE 2: DRUGS USED IN THE PAST 7 DAYS, BY PERCENT, 2021



Key Findings
