III. Renovation Restoration Project Issues: AKA low income tax credit program: Commissioner Wheeler responded to a question asked by the Housing Finance Authority (HFA) as to the extent of East Gainesville with regard to Low Income housing Development projects. It has been determined that projects east of main street to the city limit/urban boundaries is considered "East of Gainesville". These projects will be presented to the BOCC prior to any action by the HFA and Low income Housing tax credits.

Exceptions: Veterans and Seniors projects. However, it is the contention of the HFA that all projects regardless of location with the City Limits of Gainesville will first be brought to the attention of the BOCC.

**Question:** Does it usually take this long for a CDBG Grant to be approved? **Response:** Time frame of the CDBG Grant submission by Alachua County Community Support Services —

- 1. In October, 2022 Submitted the CDBG Grant
- 2. In January, 2022-Awarded by the Governor
- 3. In July, 2022 Received the Award Letter
- 4. On the second week of October, 2022 received contract to sign
- 5. Within 4 days submitted to the Alachua County Board of Commissioner agenda and signed (new record)
- 6. Since the second week of October, 2022 the contract has been in State of Florida Office in Tallahassee. Florida

## VI. Upcoming Replacement Housing Program (part of the LHAP)

Mr. Weeks presented new plan to assist with Senior's mobile or modular home replacement for Alachua County residents outside the city limits and to provide the following.

- i. Meet Hurricane codes
- ii. Provide Energy Efficiency
- iii. Provide Cost Savings Expense
- iv. LHAP states not to exceed \$150,000.00 limit
- v. Will present the research survey results when completed

#### Discussion:

**Question:** What are the problems with acquiring contractors for the Home Repair program? **Response:** Profit margin not high enough for some contractors and there seems to be an abundance of work, and finally materials are still in short supply, therefore the contractors are hold on the supply for large more lucrative jobs.

Questions: Are we strict about modifying cost?

**Response:** Yes, we do not like change orders. However there are going to be times when change orders are necessary.

**Questions:** How many property available and is there a waiting list? **Response:** There are approximately 28 Escheated Properties available.

There is no waiting list for escheated properties.

## County Attorney Representative informed of the Escheated Properties process:

- Properties identified where residents did not pay their property taxes-
- No one bid on the properties therefore they were escheated to Alachua County
- The County decides if they need demolition or repair to become habitable

## Relationship with AHAC and Alachua County Public Housing

- Alachua County Housing representative informed the waiting list was open and closed a view days ago
- Alachua County Housing Initiative partnered with Alachua County Housing Authority and with Family Promise, who identified 10 families to receive housing assistance.

**Question**: Will mobile or modular homes be placed on any of the escheated properties? **Response**: Not at this time.
