

**FIRST AMENDMENT FOR PROFESSIONAL SERVICES BETWEEN ALACHUA
COUNTY AND FOREST MEADOWS FUNERAL HOME AND CEMETERIES
NO. 13149**

THIS First AMENDMENT (“Amendment”) is made by and between Alachua County, Florida, a political subdivision, and charter county of the State of Florida, by and through its Board of County Commissioners (the “County”) and Faithful Heritage Holding, d/b/a Forest Meadows Funeral Homes & Cemeteries, a Florida Corporation which is authorized to do business in the State of Florida (“Professional”), who are collectively referred to as the “Parties”.

WITNESSETH:

WHEREAS, the County and Professional previously entered into a Professional Services Agreement dated October 26, 2021 for Indigent Burial and Cremation Services, identified by No. 13149 (the “Agreement”); and

WHEREAS, the County has elected its option to renew the term of the original Agreement to allow the Professional to furnish the goods or service to Alachua County; and

WHEREAS, the Parties desires to amend the Agreement to extend the term and to do as otherwise provided herein.

NOW, THEREFORE, the County and Professional agree to amend the Agreement as follows:

A. Amendment. Section #1, of the Agreement titled “Term”, Sub-Section 1.1 is amended to read as follows:

1.1 This Agreement is effective beginning October 26, 2021, and continues until September 30, 2023 unless earlier terminated as provided herein. This Agreement may be amended at the option of the County for 1 additional 1 year term at the terms and conditions contained in this Agreement.

B. Effective Date. Upon and after full execution of this Amendment by the Parties, this Amendment shall be effective on October 1, 2022.

C. Original Agreement. Unless expressly amended herein, all other terms and provisions of the original Agreement between the Parties, including any prior amendments to the Agreement, shall be and remain in full force and effect. In the event any of the prior amendments to the Agreement conflict with this Amendment, the provisions of this Amendment shall prevail.
