### **NOTICE OF PUBLIC HEARING**

NOTICE IS HEREBY GIVEN that the Board of County Commissioners of Alachua County, Florida (Board), has received a proposal for public-private cooperation pursuant to §336.71, Florida Statutes, from North Florida Regional Medical Center, Inc. (NFRMC) offering to realign a segment of SW 41st Boulevard near the intersection of I-75 and State Road 24. At its meeting to be held on August 22, 2023, at 11:30 a.m., or as soon thereafter as the matter may be heard, the Board will consider whether it is in the public interest to accept the proposal and enter into an agreement with NFRMC to design and construct said realignment at no cost to the County, but in exchange for the County conveying a drainage easement to NFRMC. The hearing will be held at the Alachua County Administration Building, 12 SE 1st Street, Second Floor, Jack Durran Auditorium, Gainesville, Florida 32601.

The cost estimate for the project, and the proposed resolution to approve the realignment of SW 41st Boulevard and to award the contract to design and construct said realignment to NFRMC, is available for review at: <http://www.alachuacounty.us/Pages/Ordinance-Advertisements.aspx>. A copy of the cost estimate and proposed resolution are also available at 12 SE 1st Street, Second Floor, County Manager's Office, Gainesville, Florida 32601, between the hours of 8:30 a.m. through 5:00 p.m., Monday through Friday (excluding County recognized holidays).

All persons are advised that, if they decide to appeal any decision made at this public hearing, they may need a record of the proceedings and, for such purpose, they may need to ensure that a verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is to be based.

All interested persons may attend and provide public comment. Masks for vulnerable citizens are strongly recommended.

Meetings may be broadcast over Cox Channel 12 and the County's Video on Demand website. The public may submit written comments and documents to the Board through email ([bocc@alachuacounty.us](mailto:bocc@alachuacounty.us)) before the meeting.
