Background:

In fiscal year 2017 (FY2017), the Public Works Department needed a more complete asset and work management software system to manage the County's infrastructure. After reviewing several asset and work management software, it was determined that Cityworks would meet the department's needs best. Since 2017 the system has been deployed to Facilities also.

On April 17, 2017, a License and Maintenance agreement was signed for the purchase and implementation of Cityworks Server Asset Management System (AMS). The proprietary AMS software is only available through a fully executed Software License and Maintenance Agreement with Azteca Systems, LLC. In fiscal year 2022, CityWorks was renewed using a PO in the amount of \$50,000. On March 14, 2023, the Board approved Amendment 5 for the renewal of Azteca Systems, LLC for \$62,798 covering the period from 04/01/23-03/31/24.

Information & Telecom Services manages the Azteca Systems LLC Contract. Amendment 6 will add the OpX Contracts product to the Cityworks Enterprise License Agreement for Public Works. The OpX Contracts add-on is a Cityworks tool which provides a GIS-centric platform for creating, editing, and managing projects. Cityworks also incorporates contract management capabilities within OpX Contracts that can be used to load, update, and manage contract line items, and contractor activities.
