# FIRST AMENDMENT TO AGREEMENT FOR ANNUAL PROPERTY APPRAISAL SERVICES WITH SANTANGINI APPRAISALS, LLC NO. (#)13639

THIS FIRST AMENDMENT ("Amendment") is made by and between Alachua County, Florida, a political subdivision and charter county of the State of Florida, by and through its Board of County Commissioners (the "County") and Santangini Appraisals LLC, a Florida limited liability company which is authorized to do business in the State of Florida ("Professional"), who are collectively referred to as the "Parties".

#### WITNESSETH:

**WHEREAS**, the County and Professional previously entered into a(n) Continuing Services Agreement, dated 01/17/2023, for Annual Property Appraisal Services, identified by No. 13639 (the "Agreement"); and

**WHEREAS**, the County has elected its option to renew the term of the original Agreement to allow the Professional to furnish the goods or service to Alachua County.

**NOW, THEREFORE**, the County and Professional agree to amend the Agreement as follows:

- A. <u>Amendment</u>. Section #3, of the Agreement titled "*Term*" is amended to read as follows:
  - 3. <u>Term.</u> This Agreement is effective upon execution by both Parties ("effective date"), and continues until September 30, 2025, unless earlier terminated as provided herein. This Agreement may be amended at the option of the County for one additional two-year term. Professional may choose not to renew this Agreement with the County provided the County has received written notice from the Professional ninety (90) days prior to the fiscal year start date of October 1<sup>st</sup> for each renewal term.
- B. <u>Effective Date</u>. Upon and after full execution of this Amendment by the Parties, this Amendment shall be effective on October 1, 2023.
- C. <u>Original Agreement</u>. Unless expressly amended herein, all other terms and provisions of the original Agreement between the Parties, shall be and remain in full force and effect.
