Solicitation Award and Contracts #13726 and #13727 for Invitation to Bid (ITB) 23-947 County Road 325 over Cross Creek and CR 241 over Santa Fe River-Bridge Rehabilitation - Project # 919-7903-FY19-260027 & 919-7903-FY19-260086 to E&D Contracting Services, Inc., in the amount of \$1,160,220.00, for Public Works.

Approve the Solicitation Award and Contracts for ITB 23-947 CR 325 over Cross Creek and CR 241 over Santa Fe River-Bridge Rehabilitation and authorize the Chair to sign the contracts:

#13727 Project No. 919-7903- FY19-260086- CR241 over Santa Fe River in the initial contract amount of \$685,450.00 and a 5% contingency of \$34,272.50

#13726 Project No 919-7903-FY19 -260027- CR 325 over Cross Creek in the initial contract amount of \$474,770.00 and a 5% contingency of \$23,738.50

Project approved in the FY19 Capital Improvement Plan (CIP) with Funding increased in the Transportation Capital Improvement Program (TCIP) approved on 5/23/2023.

Fiscal Note:

Budget set in TCIP on 5/23/2023. For project 919-7903-FY19-260027 (CR325) a total of \$585,303.00 is allocated in account 341.79.7910.541.63.99. For project 919-7903-FY19-260086 (CR241) a total of \$857,214.00 is allocated in account 341.79.79101.541.63.99.

Infrastructure

Background:

This project is to rehabilitate two bridges: CR 325 over Cross Creek and CR 241 over Santa Fe River. The work involves repairs recommended by the Florida Department of Transportation including joint sealing, crack repairs, scour mitigation, beam repairs, pile repairs, and cap repairs. Work is expected to commence in August 2023 and reach completion in spring 2024.

ITB 23-947 CR 325 over Cross Creek and CR 241 over Santa Fe River-Bridge Rehabilitation was released March 1, 2023. The deadline for receipt of ITB 23-947 CR 325 over Cross Creek and CR 241 over Santa Fe River-Bridge Rehabilitation was April 12, 2023; three (3) vendors responded.
