FIRST AMENDMENT TO AGREEMENT FOR ANNUAL PAVEMENT MARKING SERVICES WITH P&P STRIPING, LLC NO. (#)12087

THIS FIRST AMENDMENT ("Amendment") is made by and between Alachua County, Florida, a political subdivision and charter county of the State of Florida, by and through its Board of County Commissioners (the "County") and P&P Striping, LLC, a Florida Limited Liability Corporation which is authorized to do business in the State of Florida ("Contractor"), who are collectively referred to as the "Parties".

WITNESSETH:

WHEREAS, the County and Contractor previously entered into a(n) Contractual Services Agreement dated 10/26/2021 for Annual Pavement Marking Services, identified by No. 12087 (the "Agreement"); and

WHEREAS, the County has elected its option to renew the term of the original Agreement to allow the Contractor to furnish the goods or service to Alachua County; and

WHEREAS, the Parties desires to amend the Agreement to extend the term and to do as otherwise provided herein.

NOW, THEREFORE, the County and Contractor agree to amend the Agreement as follows:

- 1. Amendment. Sub-Section #1.1, of the Agreement titled "Term" is amended to read as follows:
 - 1.1. This Agreement is effective upon execution ("Effective Date") through September 30, 2024, unless earlier terminated as provided herein. The County has the option of renewing this Agreement for one (1) additional two (2) years period at the same terms and conditions outlined herein.
- Amendment. Sub-Section #4.1, of the Agreement titled "Method of Payment" is amended to read as follows:
 - 4.1. The Contractor shall be paid a sum not to exceed Two Hundred Thousand Dollars and Zero Cents (\$200,000.00), for the period commencing on the Effective Date and continuing through September 30, 2022, based on the fee schedule (schedule of values) attached hereto as Exhibit 2. During the period of the First Renewal Option Term (October 1, 2022 through September 30, 2024), payment shall be based on the fee schedule (schedule of values) attached hereto as Exhibit 2-A, with a sum not to exceed Two Hundred Thousand Dollars and Zero Cents (\$200,000.00).
- 3. <u>Effective Date</u>. Upon and after full execution of this Amendment by the Parties, this Amendment shall be effective on October 1, 2022.
- 4. <u>Original Agreement</u>. Unless expressly amended herein, all other terms and provisions of the original Agreement between the Parties, including any prior amendments to the Agreement, shall be and remain in full force and effect. In the event any of the prior amendments to the Agreement conflict with this Amendment, the provisions of this Amendment shall prevail.
