# FIRST AMENDMENT TO AGREEMENT NO. 7794 BETWEEN ALACHUA COUNTY AND EMS TECHNOLOGY SOLUTIONS LLC

THIS FIRST AMENDMENT TO AGREEMENT NO. 7794, made and entered into this <u>151</u> day of <u>1019</u> A.D. 20<u>20</u>, by and between Alachua County, a charter county and political subdivision of the State of Florida, by and through its Board of County Commissioners, hereinafter referred to as "County", and EMS TECHNOLOGY SOLUTIONS LLC, hereinafter referred to as "Contractor". Collectively the County and the Contractor are hereinafter referred to as the "Parties".

## WITNESSETH:

WHEREAS, the parties hereto previously entered into the *Agreement for Contractual Services* dated November 30, 2011, for the provision of the implementation of AmbuTrak Inventory Management Software and Support ; and,

WHEREAS, the parties wish to amend the Agreement to add a Usee License to support an additional Fire Rescue Station and to add a provision to allow the Parties to execute this Amendment and any future Amendments digitally;

NOW, THEREFORE, the parties hereby agree to amend the Agreement as follows:

A. SECTION # 4.2 of the Agreement, Products and Services, is amended to increase the line AmbuTrak License Fee (Monthly) to read:

B. The following provision is added to the Agreement as Section 27:

#### 27. Electronic Signatures.

The Parties agree that an electronic version of this Agreement shall have the same legal effect and enforceability as a paper version. The Parties further agree that this Agreement, regardless of whether in electronic or paper form, may be executed by use of electronic signatures. Electronic signatures shall have the same legal effect and enforceability as manually written signatures. The County shall determine the means and methods by which electronic signatures may be used to execute this Agreement and shall provide the Contractor with instructions on how to use said method. Delivery of this Agreement or any other document contemplated hereby bearing an manually written or electronic signature by facsimile transmission (whether directly from one facsimile device to another by means of a dial-up connection or whether mediated by the worldwide web), by electronic mail in "portable document format" (".pdf") form, or by any other electronic means intended to preserve the original graphic and pictorial appearance of a document, will have the same effect as physical delivery of the paper document bearing an original or electronic signature.

C. This FIRST amendment shall take effect upon the date of execution by the parties.

**SAVE and EXCEPT** as expressly amended herein, all other terms and provisions of the Agreement shall be and remain in full force and effect.
