I Gotcha Back Education (IGB) operates with the intention of serving ALL children of Alachua County with a focus on the underserved population. Over the last two years, 77% of IGBs participants have been from the under-resourced community. The IGB program focuses on developing its participants by focusing on 4 core areas: Emotional Wellness, Communication Skills, Inquiry Skills, and Financial Literacy. In recent years our local students have had a wide disparity in academic outcomes and achievement gaps compared to the entire state of Florida. Among Florida's 75 districts, Alachua's difference in achievement for students in our target audience was the most significant. During the 2021-2022 school year, there was a 53% variance in English Language Arts (ELA) achievement level, and a 58% variance for math achievement level (Florida Department of Education, 2022).

The **IGB Into the Future project** will allow IGB to provide access to improved technology that many of our participants might not have otherwise. As we saw with the school shutdowns due to the 2020 COVID pandemic, many of our underserved students did not have computer access at home, and those with access didn't know how to effectively use their computers or lacked familiarity with the computer. This project will allow our students to develop computer skills in areas such as typing, programming, learning-based applications, and research. This will also be helpful in bridging the gap in the lack of computer literacy at home for many students. It gives IGB the opportunity to differentiate and expand our current offerings with varying types of technology-based learning as well as allowing participants the ability to do online projects, more collaborative projects, and virtual field trips. With the use of this type of technology, it also allows IGB to be more efficient in collecting data. This data collection will benefit both the participants with improved offerings as well as IGB in our ability to track outcomes.

In all, there exists a need for programming such as IGB within Alachua County especially in the key developmental years of K-5th grade as minorities with lower income status have a direct negative correlation to academic achievement in Alachua County. Students who do not partake in enrichment activities can miss out on opportunities to improve academic and social outcomes.

The IGB Education Program has been in operation since August 2007. The program originated at Eastside High School to help students that were falling behind to develop or improve the necessary skills needed to meet graduation requirements. It allowed those students to gain a support system and an opportunity to develop a bond with a mentor who could help them become college and career ready.

Over the last 3 years, the IGB program has expanded because we've realized that to have an even greater impact, we have to reach students before they reach high school. We have partnered with NCFL YMCA, AskMeno.com, established financial institutions, mental health providers, and Peak Literacy to help develop our program offerings. IGB now offers programming for K-5th grade through our Mentoring After School Program (MAP) and our Summer Enrichment Camp (SEC).

The IGB - Into the Future project can help provide a more engaging learning environment. By having iPads, and laptops we can present subjects in a more interactive and dynamic way to our students through platforms like Google Classroom and Drive. This shift to digital resources will enhance and expedite the delivery of instruction and significantly reduce the reliance on paper, which slows student completion. One of the challenges we currently face is a low computer-to-student ratio, which impacts the operation, learning, and timing of program offerings, like Askmeno.com interactions. The low computer-to-student ratio deters our ability to involve more students in discussions and limits their access to essential technology resources. This project is particularly crucial as we implement learning-based software, like Peak Literacy, to improve reading and math levels. With IGBs new technology-based infrastructure, we can effectively bridge the gap in computer literacy among our students. The availability of devices like iPads will create a new line of communication with students. Educators will be able to use these platforms to explain and clarify curriculum materials, which is crucial since our staff and students' success is dependent on how well they can connect and communicate with one another. Funding for this project will also allow us to be more efficient and effective in collecting data to improve interactions and outcomes.

At the time in which we receive the items needed for IGB-Into the Future project, we will immediately integrate them into our program's daily curriculum. Our Mentoring Afterschool Program (MAP) and Summer Enrichment Camp (SEC) will be the initial platforms for implementing these resources. By the end of the upcoming school year, we aim to have all of IGB fully digital, revolutionizing our approach to education. To achieve this goal, we will take several necessary steps. Firstly we will establish a Google Classroom platform to serve as a central hub for students and educators to access lessons and activities. This digital platform will provide participants with a seamless and interactive learning experience. As well as allow educators to monitor student participation, assess their performance, and provide timely feedback. This streamlined digital program will allow us to evaluate the impact of our program on individual students and allow us to identify areas of improvement. Additionally, we will develop a student portal designed specifically for our homeschooling and hospital-homebound students who may need school emails or logins. This student portal will be similar to the ones utilized by public schools. However, it now will allow homeschooled and homebound students to access and benefit from various academic resources they did not have before and ensure every child can partake in our program.
