Background:

Office of the State Attorney for the 8th Judicial Circuit (SAO8) receives and processes nearly 20,000 individual criminal cases every year. These items of evidence originate from over 25 different law enforcement agencies, victims, witnesses, governmental entities, and others. Every year the quantity of digital forensic evidence grows significantly. For example, in 2022, SAO8 downloaded 249,180 individual items of digital forensic evidence, averaging 20,765 items per month. In 2023, that average has increased to 28,607 items per month. Under the current software system, each item of evidence must be reviewed individually by a staff member and the meta-data to link that item of evidence to a case within the system must be entered manually. This practice is not sustainable. SAO8 seeks to purchase software that automates this process by encoding the evidence for processing at the originating entity.

SAO8 has reviewed multiple systems to modernize its practices to achieve the goal set out above. NICE Justice solution is the only proven product that meets our needs. The main function of this cloud-based, SaaS (Software-as-a-Service) software is to serve as a central point of collection, analysis and sharing of all types of digital evidence from all sources, enabling complete, fast, and secure information

exchange among users at SAO8, and its criminal justice system partners. This product will benefit the entire court system by creating increased efficiency in handling, processing, interpreting, delivering, and evaluating all forms of digital forensic evidence.
