Prior Board Motions:

June 28, 2022 - The BOCC adopted Resolution 22-066 which establishes the process for selecting and acquiring environmentally significant lands using Wild Spaces and Public Places local government infrastructure surtax proceeds.

<u>Santa Fe River – Waldo Tree Farm Property</u>

November 8, 2022 - The BOCC approved and authorized the Chair to exercise the Santa Fe River – Waldo Tree Farm Option Contract to purchase Real Property.

September 22, 2020 – The BOCC placed the Santa Fe River – Waldo Tree Farm property on the Active Acquisition List as a Fee Simple purchase (Full Price List).

Lochloosa Slough Flatwoods – Colasante Property

March 28, 2023 - The BOCC approved and authorized the Chair to exercise the Lochloosa Slough Flatwoods – Colasante Option Contract to purchase Real Property.

December 8, 2020 – The BOCC placed the Lochloosa Slough Flatwoods – Colasante property on the Active Acquisition List as a Fee Simple purchase (Full Price List).

<u>Lake Santa Fe – Dinh Property</u>

March 28, 2023 - The BOCC approved and authorized the Chair to exercise the Lake Santa Fe - Dinh

Option Contract to purchase Real Property.

January 11, 2005 – The BOCC placed the Lake Santa Fe - Dinh property on the Active Acquisition List as a Fee Simple purchase (Full Price List).

Fiscal Note:

WALDO TREE FARM TOTAL ALL COSTS - \$453,534.56, COLASANTE TOTAL ALL COSTS - \$1,896,071.63, and DINH TOTAL ALL COSTS (ALACHUA COUNTY PORTION) - \$428,918.29. These are the final totals for these three properties: individual amounts are listed in the attached report.
