WHEREAS, the Board has reviewed the inventory list, a copy of which is attached hereto, and adopts this resolution at a public hearing held before the Board.

- 2. <u>Inventory</u>. The inventory list attached to this Resolution as Exhibit "A" is the inventory list of County property appropriate for affordable housing as set forth in and as required by Section 125.379, Florida Statutes.
 - 3. <u>Disposition</u>. Disposition of the properties set forth on the inventory list attached
