## **Description:**

Request Approval of Joint Wild Spaces Public Places and Infrastructure Projects with the City of Newberry

#### **Recommended Action:**

Approve the City of Newberry's two applications for Municipal Partnership Program surtax grant funding, one for WSPP grant funding in an amount not to exceed \$200,000 and one for Other Infrastructure grant funding in an amount not to exceed \$333,333.00; authorize County staff to finalize the Grant Agreements using the attached Form Grant Agreement, and upon approval from the County Attorney's Office authorize the Alachua County Chair and Clerk to sign the Grant Agreements.

#### **Prior Board Motions:**

August 22, 2023 – Hear presentation and approve the Joint Infrastructure Surtax Projects Application form as proposed.

May 23, 2023 – Approve equal distribution between all nine cities (\$333,333 for Wild Spaces Public Places and \$333,333 for Infrastructure). Staff is to develop a standard application form to detail how the grant provides both countywide significance as laid out in the statute, and local significance for their respective municipality and that the form be reviewed by the Oversight Board.

#### **Fiscal Note:**

Not to exceed \$200,000 of the City of Newberry's allocated \$333,333 in joint Wild Spaces Public Places partnership project funding and \$333,333 in joint Infrastructure partnership project funding. Funding for Infrastructure projects is budgeted in Fund 142.

## Background:

Section 5 of Ordinance 22-08 establishes "Alachua County's Non-Recurring Municipal Partnership

Program" to be allocated among the County's nine municipalities, which sets aside \$3 million of the County's infrastructure surtax proceeds for joint WSPP Projects and another \$3M for Other Infrastructure Projects. The grant programs require matching funds from the municipal applicants and all grant funding is payable by the County on a reimbursement basis after the project has been completed. On May 23, 2023, the Board directed that each \$3M pool of Grant Funding be allocated equally between all nine municipalities (*i.e.*, \$333,333.33 per municipality per grant program). The City of Newberry has submitted an application for grant funding under each of the two programs. One application seeks an amount not to exceed \$200,000.00 in WSPP Grant Funding that will be used to construct a paved parking lot at Jimmy Durden Park, and the other seeks an amount not to exceed \$333,333.33 in Other Infrastructure Grant Funding to reconstruct a portion of SW 15<sup>th</sup> Avenue near the intersection of CR 337 (this Project, while adjacent to the Newberry's Environmental Park is mostly unrelated).
