

FIRST AMENDMENT TO AGREEMENT BETWEEN ALACHUA COUNTY AND ALACHUA COUNTY COALITION FOR THE HOMELESS AND HUNGRY, INC., NO. 13975

THIS FIRST AMENDMENT (“Amendment”) is made by and between Alachua County, Florida, a political subdivision and charter county of the State of Florida, by and through its Board of County Commissioners (the “County”) and Alachua County Coalition for the Homeless and Hungry, Inc. doing business as GRACE Marketplace, a Florida not-for-profit corporation (“Agency”), who are collectively referred to as the “Parties”.

WITNESSETH:

WHEREAS the County and Agency previously entered into an Agreement dated November 20, 2023 for Budget Enhancement, identified by No. 13975 (the “Agreement”); and

WHEREAS, the Agency has requested to re-allocate funds within the current budget, with no modification to the Scope of Services agreed to in the Agreement; and

WHEREAS County has determined that the requested re-allocation of the funds is acceptable and meets the intent of the Agreement; and

WHEREAS, the Parties desire to amend the Agreement to codify the re-allocation of funds.

NOW, THEREFORE, the Parties agree to amend the Agreement as follows:

- A. Amendment. Exhibit #3, of the Agreement titled “Proposed Budget” is amended in its entirety and replaced with the Proposed Budget attached to this Amendment.
- B. Effective Date. This Amendment shall be effective upon execution by both Parties.
- C. Original Agreement. Unless expressly amended herein, all other terms and provisions of the original Agreement between the Parties, including any prior amendments to the Agreement, shall be and remain in full force and effect. In the event any of the prior amendments to the Agreement conflict with this Amendment, the provisions of this Amendment shall prevail.
