First Amendment to Agreement 13921 with Boone Improvements, Inc., for Bid 24-34 Annual Lawn Maintenance at NW and SW Landfills and Rural Collection Centers, not to exceed \$75,000.00 annually, for Solid Waste and Resource Recovery. This amendment is to update Exhibit 2: Rate Schedule.

June 27, 2023, the Board of County Commission approved the Award of Bid 24-34 Annual Lawn Maintenance NW and SW Landfills and Rural Collection Centers, to Boone Improvements Inc., in the amount of \$67,207.40, for Solid Waste and Resource Recovery. Agenda Item 23-00254.

### **Fiscal Note:**

Budget to cover not to exceed amount are included in the tentative Fiscal Year 2024 (FY24) budget in accounts: 403.76.7610.534.46.00=\$17,265; the Rural Collection Centers Fund, 405.76.7633.534.46.00=\$37,548.59; the Waste Management Assessment Fund and 406.76.7650.534.46.00=\$17,715.00; the Closure/Post Closure Fund. All the accounts are in the operating category with the description of repair and maintenance services.
