

**FIRST AMENDMENT TO AGREEMENT BETWEEN ALACHUA COUNTY AND
REBUILDING TOGETHER NORTH CENTRAL FLORIDA, INC.
FOR ENERGY EFFICIENCY AND WEATHERIZATION OF
AFFORDABLE HOUSING GRANT PROGRAM MANAGEMENT SERVICES NO. 13489**

THIS AMENDMENT ("Amendment") is made by and between Alachua County, Florida, a political subdivision and charter county of the State of Florida, by and through its Board of County Commissioners (the "County") and REBUILDING TOGETHER NORTH CENTRAL FLORIDA, INC, a Not-for-Profit Corporation which is authorized to do business in the State of Florida ("Contractor"), who are collectively referred to as the "Parties".

WITNESSETH:

WHEREAS, the Parties previously entered into an Agreement dated December 20, 2022, for Energy Efficiency and Weatherization Of Affordable Housing Grant Program Management Services, identified by No. 13489 (the "Agreement"); and

WHEREAS, the Parties desire to amend the Agreement to modify a part of the Scope of Services in the Agreement, and to do as otherwise provided herein.

NOW, THEREFORE, the County and Contractor agree to amend the Agreement as follows:

A. **Amendment.** Paragraph 7.5.4 of Exhibit #1, attached to the Agreement titled "Scope of Services" is amended to read as follows:


7.5.4 Water Heaters. Install an appropriately sized, high-efficiency water heater that meets or exceeds ENERGY STAR standards.

B. **Effective Date.** This Amendment shall be effective upon execution by both Parties.


C. **Original Agreement.** Unless expressly amended herein, all other terms and provisions of the original Agreement between the Parties, including the Exhibits to the Agreement, shall be and remain in full force and effect. In the event any of the prior amendments to the Agreement conflict with this Amendment, the provisions of this Amendment shall prevail.
