Software and Service Agreement Between **Alachua County** and **connectrex corp**Amendment 1

This is an amendment to the Software and Services Agreement between **Alachua County** and **connectrex corp** (formerly Loryx Systems) dated September 12, 2006.

It is the intent of the parties to acknowledge the following terms and conditions,

- connectrex corp shall provide the MonitorConnect self-reporting and reminder services to defendants
 of Alachua County through its existing Monitor Enterprise Client Management System.
- 2) MonitorConnect is offered on a "participant month" basis. A participant month is defined as 1 (one) defendant enrolled in the service for 1 (one) month (minimum).
- 3) This amendment is limited to 3,600 (three thousand six hundred) participant months.
- 4) Alachua County shall pay, upon execution of this amendment, \$20,000 (twenty thousand dollars) for all costs associated with *MonitorConnect* for a term of 1 (one) year.
- 5) connectrex corp offers all MonitorConnect services including
 - a. Weekly Reporting Reminder Schedule for Defendants:
 - (3) Reminders (1 week before, day before, day of) + 1 late reminder if defendant fails to report-in by each Friday at 11:59p.
 - (2) Court Reminders (1 week before, 1 day before)

Guaranteed up to 20 reminders per month by Text Message and email (with valid email address) – or up to 20 reminders per month through automated voice notification and email (with valid email address).

6) All other terms and conditions of the above referenced agreement shall remain the same.

Executive Summary

Due to a reduction in staff and increased caseloads for pretrial supervision, Court Services is exploring innovative ways to supervise pretrial defendants. Placing defendants on MonitorConnect will allow Court Services to better manage these larger caseloads and will allow the defendants the opportunity to call at a time most convenient to them while still maintaining defendant accountability.

Background

On September 12, 2006, the Board approved the purchase of Loryx Systems, a supervision software for community correction agencies. MonitorConnect is an addition to the original software. This addition is an innovative web and phone based collection of supervision services including automated appointment reminders, on-line and phone offender reporting, offender on demand access to information including agency forms and documents, and networking of social service agencies. With MonitorConnect, offenders can answer agency configurable questions, update their address and employment information, and send and receive messages from their case managers.
