SECOND AMENDMENT TO AGREEMENT FOR ANNUAL ASPHALTIC CONCRETE SURFACING SERVICES WITH CREATIVE CONCRETE DESIGN OF COLUMBIA COUNTY, INC. NO. 13740

THIS SECOND AMENDMENT ("Amendment") is made by and between Alachua County, Florida, a political subdivision and charter county of the State of Florida, by and through its Board of County Commissioners (the "County") and Creative Concrete Design of Columbia County, Inc., a Florida Corporation which is authorized to do business in the State of Florida ("Contractor"), who are collectively referred to as the "Parties".

WITNESSETH:

WHEREAS, the County and Contractor previously entered into an Agreement dated 03/29/2023, for Annual Asphalt Concrete Surfacing Services, identified by No. 13740 (the "Agreement"); and

WHEREAS, the County has elected its option to renew the term of the original Agreement to allow the Contractor to furnish the goods or service to Alachua County; and

WHEREAS, the Parties desires to amend the Agreement to extend the term and to do as otherwise provided herein.

NOW, THEREFORE, the County and Contractor agree to amend the Agreement as follows:

- A. Amendment. Section #3, of the Agreement titled "Term" is amended to read as follows:
 - 3. <u>Term</u>. This Agreement is effective upon execution ("effective date"), and continues until September 30, 2025, unless earlier terminated as provided herein.
- B. <u>Amendment</u>. Sub-Section #5.A, of the Agreement titled "Payment" is amended to read as follows:
 - A. The County will pay Contractor for timely and completed Services as described in this Agreement. The Parties agree that the amount to be paid to Contractor, for the Services, will not exceed **Three Million, Six Hundred Thousand Dollars and Zero Cents (\$3,600,000.00)** ("NTE amount") per Fiscal Year. For the purposes of this Agreement, a fiscal year is from October 1st through September 30th. Payment will be in accordance with the <u>Rate Schedule</u> attached as Exhibit "2" and incorporated herein.
- C. Effective Date. This Amendment shall be effective upon and after full execution by the Parties.
- D. <u>Original Agreement</u>. Unless expressly amended herein, all other terms and provisions of the original Agreement between the Parties, including any exhibits and any prior amendments to the Agreement, shall be and remain in full force and effect. In the event any of the prior amendments to the Agreement conflict with this Amendment, the provisions of this Amendment shall prevail.
