**Third Amendment 12087 with P&P Striping, LLC for Bid 22-6 Annual Pavement Marking Services for Public Works.**

**Description:**

Third Amendment 12087 with P&P Striping, LLC for Bid 22-6 Annual Pavement Marking Services for Public Works, not to exceed (NTE) \$1,500,000.00 annually, for Public Works. This amendment increases the not to exceed amount from \$200,000.00 to \$1,500,000.00 and renews the term through September 30, 2026.

**Recommended Action:**

Approve and authorize the Chair to execute Third Amendment 12087 with P&P Striping, LLC for Bid 22-6 Annual Pavement Marking Services, not to exceed (NTE) \$1,500,000.00 annually.

**Prior Board Motions:**

July 11, 2023, the Board approved the Second Amendment to Agreement #12087, to P&P Striping, LLC., for BID 22-6 Annual Pavement Marking Services and authorize the Chair to execute same on behalf of the County. Item # 23-00281.

September 13, 2022, the Board approved the First Amendment #12087, to P&P Striping, LLC., for BID 22-6 Annual Pavement Marking Services, in an amount not to exceed (NTE) \$200,000.00 annually and authorize the Chair to execute same on behalf of the County. Item # 22-0676.

October 26, 2021, the Board approved the solicitation award and contracts for BID 22-6 Annual Pavement Marking Services to (1) Roadscape North Florida, Inc. (Primary) and (2) P&P Striping, LLC (Secondary), in an amount not to exceed (NTE) \$200,000.00 each annually, as the lowest responsible and responsive bidders meeting specifications, and authorize the Chair to execute same on behalf of the County. Item # 21-0908.

**Fiscal Note:**

The increase requested is directly related to pavement marking services needed and included in capital road projects in funds including but not limited to 50% of 1 cent Surtax Other Uses, Transportation Trust Fund, and 5-cent Local Option Gas Tax Fund.

**Background:**

Agreement #12087 to P&P Striping, LLC., for Annual Pavement Marking Services has a not-to-exceed amount of \$200,000.00 for the annual second renewal period of October 1, 2022, through September 30, 2024. Alachua County Public Works has increased needs for its Annual Pavement Marking Service Agreement for pavement markings on its capital projects, annual pavement marking maintenance and miscellaneous projects. An amendment to the Agreement is needed to increase the not-to exceed amount from \$200,000.00 to \$1,500,000.00. The Agreement can be used for annual pavement marking maintenance and upcoming capital projects.

BID 22-6 Annual Pavement Marking Services advertised on April 28, 2021. The Deadline for receipt of BID 22-6 Annual Pavement Marking Services was June 2, 2021; two (2) vendors responded.
