

THIRD AMENDMENT TO AGREEMENT FOR ANNUAL PAVEMENT MARKING SERVICES WITH P&P STRIPING, LLC, NO. 12087

THIS THIRD AMENDMENT ("Amendment") is made by and between Alachua County, Florida, a political subdivision and charter county of the State of Florida, by and through its Board of County Commissioners (the "County") and P&P Striping LLC, a Florida limited liability company which is authorized to do business in the State of Florida ("Contractor"), who are collectively referred to as the "Parties".

WITNESSETH:

WHEREAS, the Parties previously entered into a(n) Contractual Services Agreement dated October 26, 2021, for Annual Pavement Marking Services, identified by No. 12087 (the "Agreement"); and

WHEREAS the Parties previously entered into the First Amendment to the Agreement through which the term of the Agreement was extended through September 30, 2024 (the "First Amendment"); and

WHEREAS, the Parties previously entered into the Second Amendment to the Agreement, dated July 12, 2023, through which the not to exceed amount set out in the Agreement was increased from \$200,000 to \$730,000.00 due to the County experiencing a higher-than-expected requirement; and

WHEREAS, the County has elected its option to renew the term of the original Agreement to allow the Contractor to furnish the goods or services to Alachua County and to increase the annual not to exceed amount of the Agreement for the renewal term; and

WHEREAS, the Parties desires to amend the Agreement to extend the term and to do as otherwise provided herein.

NOW, THEREFORE, the County and Contractor agree to amend the Agreement as follows:

- A. Amendment. Sub-Section #1.1, of the Agreement titled "Term" is amended to read as follows:
 - 1.1. This Agreement is effective upon execution ("Effective Date") through September 30, 2026, unless earlier terminated as provided herein.
- B. Amendment. Sub-Section #4.1, of Section 4 of the Agreement titled "Method of Payment" is amended to read as follows:
 - 4.1. The Contractor shall be paid a sum not to exceed Two Hundred Thousand Dollars and Zero Cents (\$200,000.00) per County fiscal year, for the period commencing on the Effective Date of the Agreement (October 26, 2021) and continuing through September 30, 2022, based on the fee schedule (Schedule of Values) attached hereto as **Exhibit 2** and incorporated herein.

During the period of the First Renewal Option Term (October 1, 2022, through September 30, 2024), payment shall be based on the fee schedule (Schedule of Values) attached hereto as **Exhibit 2-A** and incorporated herein, with a sum not to exceed One Million Dollars and Zero Cents (\$1,000,000.00) per County fiscal year.

During the period of the Final Renewal Option Term (October 1, 2024, through September 30, 2026), payment shall be based on the fee schedule (Schedule of Values) attached hereto as **Exhibit 2-A** and incorporated herein, with a sum not to exceed One Million Five Hundred Thousand Dollars and Zero Cents (\$1,500,000.00) per County fiscal year.

This amount includes payments for services rendered and invoices since October 1, 2022.

C. Effective Date. This Amendment shall be effective upon and after full execution of this Amendment by the Parties.

D. Original Agreement. Unless expressly amended herein, all other terms and provisions of the original Agreement between the Parties, including any prior amendments to the Agreement, shall be and remain in full force and effect. In the event any of the prior amendments to the Agreement conflict with this Amendment, the provisions of this Third Amendment shall prevail.
