Description:

Second Amendment 13740 with Creative Concrete Design of Colombia County (Primary). This amendment extends the term until September 30, 2025, and increases the NTE (Not to Exceed) amount to \$3,600,000.00.

Second Amendment 13741 with Preferred Materials, Inc. (Secondary), and Second Amendment 13742 with V.E. Whitehurst & Sons, Inc. (Secondary) This amendment extends the term until September 30, 2025, and increases the NTE (Not to Exceed) amount to \$7,200,000.00.

Approve and authorize the Chair to execute the following Second Amendments to the following Agreements for ITB 23-07 Annual Asphalt Concrete Surfacing Services:

Second Amendment to Agreement 13740 with Creative Concrete Design of Colombia County; Second Amendment to Agreement 13741 with Preferred Materials, Inc.; and Second Amendment to Agreement 13742 with V.E. Whitehurst & Sons, Inc.

Prior Board Motions:

June 13, 2023, the Board approved the following First Amendments and authorize the Chair to sign the agreements:

First Amendment 13740 between Alachua County and Creative Concrete Design of Columbia County Inc., for Annual Asphalt Concrete Surfacing Services.

First Amendment 13741 between Alachua County and Preferred Materials, Inc, for Annual Asphalt Concrete Surfacing Services.

First Amendment 13742 between Alachua County and V.E. Whitehurst & Sons, Inc for Annual Asphalt Concrete Surfacing Services. Item 23-00145.

March 28, 2023, the Board approved the Award of Contracts for ITB 23-07 Annual Asphalt Concrete Surfacing Services for Alachua County, to Creative Concrete Design of Columbia County Inc. (Primary), Preferred Materials, Inc. (Secondary), and V.E. Whitehurst & Sons, Inc. (Secondary), for

roadway resurfacing projects as needed, in the amount not to exceed (NTE) \$1,000,000 annually each, for Public Works, and authorize the Chair to sign. Item 23-00559.

February 14, 2023, the Board approved solicitation award for ITB 23-07, Annual Asphalt Concrete Surfacing Services for Alachua County. Approving the selection of Creative Concrete Design of Columbia County Inc. (Primary), Preferred Materials, Inc. (Secondary), and V.E. Whitehurst & Sons, Inc. (Secondary), for roadway resurfacing projects as needed. Item 23-0413.

Fiscal Note:

In FY24, the funds are budgeted in the Transportation Capital Improvement Funds (TCIP). Most of the projects are being funded in the 50% of 1 cent Surtax Other Uses Fund (Fund 142) and the Transportation Trust Fund (Fund 341).

Background:

These contractors are utilized for roadway resurfacing projects as needed to supplement roadway construction and maintenance operations crews when additional resources are required. The County does not have the equipment or trained personnel to perform larger scale roadway paving operations.

Bid 23-7 Annual Asphalt Concrete Surfacing Services advertised on August 31, 2022. The deadline for receipt of BID 23-7 Annual Asphalt Concrete Surfacing Services was October 12, 2022; three (3) vendors responded, and the Board approved the solicitation award to three vendors. If approved, these Second Amendments will extend the term of the Agreements with Creative Concrete Design of Columbia County Inc., Preferred Materials, Inc., and V.E. Whitehurst & Sons, Inc. and will modify the not to exceed amount set out in each Agreement.
