SECOND AMENDMENT TO AGREEMENT FOR ANNUAL ASPHALT CONCRETE SURFACING SERVICES WITH V. E. WHITEHURST & SONS, NO. 13742

THIS SECOND AMENDMENT ("Amendment") is made by and between Alachua County, Florida, a political subdivision and charter county of the State of Florida, by and through its Board of County Commissioners (the "County") and V. E. Whitehurst & Sons, Inc., a Florida For Profit Corporation which is authorized to do business in the State of Florida ("Contractor"), who are collectively referred to as the "Parties".

WITNESSETH:

WHEREAS the Parties previously entered into an Agreement dated April 6, 2023, for Annual Asphalt Concrete Surfacing Services, identified by No. 13742 (the "Agreement"); and

WHEREAS the Parties previously entered in a First Amendment to the Agreement, dated June 20, 2023, to update the Scope of Services/Work (the "First Amendment"); and

WHEREAS, the County has experienced an unexpectedly high usage of the Services provided by the Contractor which requires an increase in the annual not to exceed amount set out in the Agreement; and

WHEREAS, the Parties desires to amend the Agreement to extend the term and to do as otherwise provided herein.

NOW, THEREFORE, the County and Contractor agree to amend the Agreement as follows:

- 1. <u>Amendment</u>. Section #3, of the Agreement titled "Term" is amended to read as follows:
 - 3. <u>Term</u>. This Agreement is effective upon execution ("effective date"), and continues until September 30, 2025, unless earlier terminated as provided herein.
- 2. <u>Amendment</u>. Subsection #5A, of the Agreement titled "Payment", is amended to read as follows:
 - A. The County will pay the Contractor for timely and completed Services as described in this Agreement. The Parties agree that the amount to be paid to Contractor for the Services will not exceed Seven Million, Two Hundred Thousand Dollars and Zero Cents (\$7,200,000.00) per County fiscal year ("NTE amount"). For the purposes of this Agreement, a fiscal year is from October 1st through September 30th. Payment will be in accordance with the Rate Schedule attached as Exhibit "2" and incorporated herein.
- 3. <u>Effective Date</u>. This Amendment shall be effective upon execution by both Parties.

4. Original Agreement. Unless expressly amended herein, all other terms and provisions of the original Agreement between the Parties, including the exhibits and any prior amendments to the Agreement, shall be and remain in full force and effect. In the event any of the prior amendments to the Agreement conflict with this Second Amendment, the provisions of this Second Amendment shall prevail.
