

INTERLOCAL AGREEMENT FOR ALLOCATION AND IMPLEMENTATION OF NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM PROGRAM REQUIREMENTS RENEWAL

THIS RENEWAL ("Renewal") is made and entered into by and between the State of Florida Department of Transportation ("Department") and Alachua County, Florida ("County"), a charter county and political subdivision of the State of Florida, by and through its Board of County Commissioners.

-RECITALS-

1. The terms and provisions set forth in this Renewal are incorporated into and made part of the Interlocal Agreement for Allocation and Implementation of National Pollutant Discharge Elimination System Program Requirements for Contract Number ASS81, Financial Project Number 21425617233 ("Agreement"), entered and executed by and between the parties June 16, 2022, a copy of which is attached as Exhibit "A"; and

2. Paragraph 3.2. Term of the Agreement, shall be extended for a period of one year and shall remain in full force and effect through December 31, 2024; and

3. The term of the Department's cost sharing responsibility to compensate the County the maximum amount not to exceed EIGHTY-SIX THOUSAND and NO/100 DOLLARS (\$86,000.00), pursuant to Paragraph 5.3 of the Agreement shall be extended up to and including December 31, 2024; and

4. All other terms and conditions of the Agreement shall remain in full force and effect.

NOW THEREFORE, in consideration of the recitals and mutual covenants and conditions in this Renewal, the parties, intending to be legally bound, acknowledge, covenant and agree as follows:

1. RECITALS

The above recitals and attached exhibits are specifically incorporated by reference and made part of this Renewal.

2. RENEWAL

A. The Department and the Contractor agree to extend the Term of the Agreement for a period of one year and shall remain in full force and effect through December 31, 2024.

B. No additional funds are being added to the Agreement and the term to compensate the County the maximum amount not to exceed EIGHTY-SIX THOUSAND and NO/100 DOLLARS (\$86,000.00), is extended up to and including December 31, 2024.

C. All other terms and conditions of the Agreement shall remain in full force and effect.
