

**FIRST AMENDMENT TO AGREEMENT BETWEEN ALACHUA COUNTY &
EDA CONSULTANTS, INC., NO. 14013**

THIS FIRST AMENDMENT (“Amendment”) is made by and between Alachua County, Florida, a political subdivision and charter county of the State of Florida, by and through its Board of County Commissioners (the “County”) and EDA CONSULTANTS, INC., a Florida for Profit Corporation which is authorized to do business in the State of Florida (“Professional”), who are collectively referred to as the “Parties”.

WITNESSETH:

WHEREAS, the Parties previously entered into a Professional Services Agreement dated January 11, 2024 for Annual Engineering Services for Civil, Structural, Mechanical, Electrical, Plumbing, and Life Safety for projects less than \$4,000,000.00, identified by No. 14013 (the “Agreement”); and

WHEREAS, the County has elected its option to renew the term of the original Agreement to allow the Professional to furnish the goods or service to Alachua County; and

WHEREAS, the Parties desires to amend the Agreement to extend the term and to do as otherwise provided herein.

NOW, THEREFORE, the County and Professional agree to amend the Agreement as follows:

A. Amendment. Section #3, of the Agreement titled “Term” is amended to read as follows:

3. Term. This Agreement is effective on the date the last Party sign it (the “Effective Date”) and the term of the Agreement shall continue through September 30, 2026, unless earlier terminated as provided herein. This Agreement may be amended at the option of the County for one additional two-year term.

B. Effective Date. This Amendment shall be effective upon and after full execution of this Amendment by the Parties.

C. Original Agreement. Unless expressly amended herein, all other terms and provisions of the original Agreement between the Parties, including any prior amendments to the Agreement, shall be and remain in full force and effect. In the event any of the prior amendments to the Agreement conflict with this Amendment, the provisions of this Amendment shall prevail.
