Dear Members of the Florida National Register Review Board,

The Alachua County Commission is pleased to support the nomination to the National Register of the African American Bethlehem Methodist Episcopal Cemetery. We thank the State Division of Historical Resources for assisting the Bethlehem Methodist Episcopal Cemetery Restoration Organization (BMECRO), the property owners, with completing the documentation of this property. This African American Cemetery, the final resting place of many once enslaved, prominent ministers, and veterans, was virtually abandoned over time. In 1999 Careatha "Clyde" Williams, a descendant, organized BMECRO to preserve the resting place of the community's ancestors and to honor their resilience in the face of enslavement, segregation and racial terror. The organization partnered with the University of Florida's Historic Preservation Program to document and restore the cemetery. In 2022 a monument, with the names of all known people buried there, was dedicated. In 2023 a State historical marker was unveiled.

The Alachua County Comprehensive Plan Historic Preservation Element includes, "Policy 1.1.4. The County shall coordinate with adjacent local governments, the State, and the Federal Government to preserve and protect historic resources and properties of local, regional and national significance." Including this property on the Nation Register will help ensure the protection of a very significant cemetery, as noted in the application document. The Alachua County Historical Commission provided a letter of support to the State Review Board, and we are glad to also support this nomination. Achieving National Register recognition of this property is part of our local effort to create a culture of respect for and preservation of our historic resources.

Should you require any assistance on this or other matters regarding Alachua County history, we are pleased to offer the assistance of the Alachua County Historical Commission, our Advisory Board of persons knowledgeable
