

FIRST AMENDMENT TO CONTRACTUAL SERVICES AGREEMENT BETWEEN ALACHUA COUNTY AND HYDRADRY INC. NO. 13482

THIS FIRST AMENDMENT (“Amendment”) is made by and between Alachua County, Florida, a political subdivision and charter county of the State of Florida, by and through its Board of County Commissioners (the “County”) and Hydradry, Inc., a For Profit Corporation which is authorized to do business in the State of Florida (“Contractor”), who are collectively referred to as the “Parties”.

WITNESSETH:

WHEREAS, the County and Contractor previously entered into a Contractual Services Agreement dated September 27, 2022 for Annual Cleaning Services for Emergency Sites, identified by No. 13482 (the “Agreement”); and

WHEREAS, the County anticipate an increase in the use of the services provided by the Contractor and desires to increase the Not to Exceed amount of the Agreement; and

WHEREAS, the County has elected its option to renew the term of the original Agreement to allow the Contractor to furnish the goods or services to Alachua County; and

WHEREAS, the Parties desires to amend the Agreement to extend the term and to do as otherwise provided herein.

NOW, THEREFORE, the County and Contractor agree to amend the Agreement as follows:

A. Amendment. Section #5, of the Agreement titled “Payment” sub-section A is amended to read as follows. All other subsections of Section #5 remain unchanged by this Amendment.

A. The County will pay Contractor for timely and completed Services as described in this Agreement. The Parties agree that the amount to be paid to the Contractor for the Services will not exceed \$75,000.00 annually ("NTE amount"). Payment will be in accordance with the Rate Schedule attached as Exhibit "2" and incorporated herein.

B. Amendment. Section #3, of the Agreement titled “Term” is amended to read as follows:

3. **Term**. This Agreement is effective upon execution by both Parties ("effective date") and continues until the September 30, 2026, unless earlier terminated as provided herein. This Agreement may be amended at the option of the County for one (1) additional two (2) year term(s) at the same terms and conditions outlined herein.

C. Effective Date. This Amendment shall be effective on upon execution by both Parties.

D. Original Agreement. Unless expressly amended herein, all other terms and provisions of the original Agreement between the Parties, including any prior amendments to the Agreement, shall be and remain in full force and effect. In the event any of the prior amendments to the Agreement conflict with this Amendment, the provisions of this Amendment shall prevail.
