# D. Adoption of the Agenda

Chair Prizzia recognized Tamara Robbins and Karen Herrington who presented comments to the Board.

**City Commissioner Duncan-Walker moved** adoption of the agenda with the addition of Public Comments at the end of the agenda. The motion carried 4-0 with City Commissioners Book, Chestnut, and Saco out of the room.

## E. Items For Discussion

1. Homeless Services Funding Gaps/Needs - 23-00509

City Manager Curry and Executive Director of GRACE John DeCarmine presented the above item.

City Manager Curry stated that currently fund in the proposed budget is \$1,050,000. The leaves a budget shortfall of \$450,000.

Mr. DeCarmine stated that the total funding request from GRACE is \$500,000. The outreach program has shortfall of \$350,000 and will cease to operate after November 30, 2023 without additional funding. The Shelter is short \$150,000 which is requested to be restored. The shelter funding would bring 10 beds back into service.

Chair Prizzia, Commissioner Cornell, City Commissioner Saco via ZOOM, Mayor Ward, Chair Prizzia, City Commissioner Chestnut, Community Support Director Claudia Tuck, Commissioner Alford, Chair Prizzia, Commissioner Chestnut, City Commissioner Eastman, City Commissioner Willits, Commissioner Wheeler, Community Support Services Director Tuck, Commissioner Alford, Mayor Ward, City Commissioner Book entered at 3:45 p.m., Commissioner Cornell, Chair Prizzia, Commissioner Chestnut, GRACE Director Jon DeCarmine, Commissioner Wheeler, and Commissioner Alford presented comments.

**Commissioner Alford moved** to fund GRACE at a \$500,000 level with \$150,000 to restore housing and \$350,000 to fund the street outreach program and direct staff to return to the Board with recommendations and a financial analysis of what a future continuum of care would look like if the County were to take it over. Failed for a lack of second.

Commissioner Chestnut, Chair Prizzia, Commissioner Wheeler, County Manager Lieberman, and Commissioner Alford presented comments.

**Commissioner Cornell moved** to provide to City of Gainesville or GRACE Marketplace a one-time \$150,000.00 of stop gap funding to bring the total GRACE funding up to \$1,500,000. Staff is to bring back a recommendation at the September 5, 2023 meeting for an additional

\$350,000 for Street Outreach funding for next year and work on a transition of the service, an outsource to the city, or a County take over with the City of Gainesville staff and GRACE Marketplace staff.
