## **MEETING MINUTES**

February 19, 2024 – 6:00 – 8:00 pm Grace Knight Conference Room 12 SE 1<sup>st</sup> Street, Second Floor Gainesville, Florida 32601

 Call to Order – Attendance and Determination of Quorum – the meeting was called to order at 6:00 PM by Chair Jennison Kipp Searcy.

- 2. Approval of Agenda—Motion to approve by John Nix, seconded by Kathryn Taubert, approved 7-0.
- 3. Review and approval of Minutes from the January 29, 2024, regular meetings— Motion made by Kathryn Taubert, seconded by Gary Kiebzak. Motion passed 7-0.
- 4. Final recommendations from last meeting presentations Jackie D. moves to support Sunshine Organics bid for the ecoloop location, Seconded by Kathryn T. Motion passed unanimously.
- Committee was impressed that they are willing to work with Broken Path and that there may be contractors that are willing to collocate with Sunshine Organics.
- Comments on Eric Walters IRP presentation
  - Jackie is concerned that IRP doesn't properly address net zero by 2045 and wants to know more about alternative models that suggest other options
    - Eric: Baseline case represents 85% reduction in emissions
      - Additional \$137 million to reach net zero emissions
      - plan will address rates as well as environment
      - Alternative model doesn't fully grasp cost and reliability requirements
  - Jennison is concerned that carbon is not priced into model and how are externalized costs handled?
    - Eric: no way to count social cost of carbon in financial model
      - What number to use?

- Jennison: is it possible to model what cost of carbon is required to make significant changes to resource selection?
- Kathryn: How are advances in battery tech worked into IRP?
  - Eric: They aren't, IRP is just redone every 3-5 yrs
- Sage: How is reliability built into the model?
  - N-1: Must be able to meet load requirements without largest generation source
  - 2:1: Solar must be backed by fast start firm capacity in a 2:1 ratio
  - Contribution of solar to peach capacity
- 5. Presentations on Flooding and legal challenges with LID on private property, presented by Shane Williams and Amanda Kohls.
- a. Shane Williams: Flooding as it pertains to citizens and infrastructure
  - County will experience more extreme and intense rainfall events
  - More runoff ==> more flooding
  - What is at risk? Roads and properties
  - Disproportionate: assisted living and affordable housing and housing around lakes/rivers/streams
  - Economic losses due to decreased property values and business loss
  - displacement of residents experiencing flooding and new development
  - Modeled county wide: 14000 storm structures
    - calibrated against Hurricane Irma and Tropical Storm Elsa
    - Current, 2040, and 2070
  - Policy categories
    - Physical infrastructure
      - pump stations
      - discharge infrastructure
      - buyouts of properties
    - Communication
      - Alachua county Ready
      - Alert Alachua
    - Finance
      - Resilient FL grants
      - HMGP grants (Hazard Mitigation Grant Program)

      - Alachua County floodplain management program
        - Provide base flood evaluations
      - Land development regulations
        - Floodplain avoidance
        - Compensating storage

  - setbacks for large floodplains

  - Planning strategy for protecting critical infrastructure
  - Special assessment districts for known flooded areas
  - Additional grant applications for state and federal grants

  - Novel legal questions
  - How can Alachua county best ensure green stormwater infrastructure can be retrofitted onto existing properties?
  - Draft Easement language
    - Doesn't affect property values much, so it is cheap to accomplish
  - Draft potential land regulations
  - Identify limitations on county power
  - Limit county and professional liability
  - Might come to a later meeting to discuss progress
