Background:

This committee was created by Resolution in 2007. The committee, in coordination with the County Office of Management and budget and the County Court Services department, shall make a formal recommendation to the county on how the CJMHSAG may best be implemented in the community.

The membership of the Advisory Board is comprised of 19 positions, as stipulated by the State, which has set forth membership requirements for the composition of the committee. This board's positions are specific, designated membership categories.

Grant Funding officially ended on March 31, 2023, and as such, the Board of County Commissioners resolved to dissolve this Advisory Board via Resolution 2023-78, in September 2023.

When it was discovered that new Grant Funding would come available in the Spring of 2024, the Board of County Commissioners, at the request of Meridian Behavioral Healthcare and Alachua County Community Support Services, re-established the CJMHSAG Advisory Board, and all rules of procedure previously followed, per State Statute.

As such, there are currently three (3) vacancies on the CJMHSAG Planning Committee, and three citizens have applied, one for each vacancy. Each position will have a 2-year term, starting on the date that they are approved by the Board of County Commissioners.
