# SECOND AMENDMENT TO AGREEMENT FOR ANNUAL PAVEMENT MARKING SERVICES WITH P&P STRIPING, LLC NO. (#)12087

THIS SECOND AMENDMENT ("Amendment") is made by and between Alachua County, Florida, a political subdivision and charter county of the State of Florida, by and through its Board of County Commissioners (the "County") and P&P Striping, LLC, a Florida Limited Liability Company which is authorized to do business in the State of Florida ("Contractor"), who are collectively referred to as the "Parties".

### WITNESSETH:

**WHEREAS** the Parties previously entered into a Contractual Services Agreement dated 10/26/2021 for Annual Pavement Marking Services, identified by No. 12087 (the "Agreement"); and

WHEREAS, the Parties previously entered into the First Amendment to the Agreement through which the term of the Agreement was extended through September 30, 2024 (the "First Amendment"); and

**WHEREAS**, the County has experienced a higher-than-expected requirement for the services provided by the Contractor which requires the increase of the cost of the Agreement from \$200,000 to \$730,000.00 for the term that ends September 30, 2024

**NOW, THEREFORE**, the Parties agree to amend the Agreement as follows:

- 1. <u>Amendment</u>. Sub-Section #4.1, of Section 4 of the Agreement titled "*Method of Payment*" is amended to read as follows:
  - 4.1. The Contractor shall be paid a sum not to exceed Two Hundred Thousand Dollars and Zero Cents (\$200,000.00), for the period commencing on the Effective Date of the Agreement and continuing through September 30, 2022, based on the fee schedule (Schedule of Values) attached hereto as Exhibit 2 and incorporated herein. During the period of the First Renewal Option Term (October 1, 2022 through September 30, 2024), payment shall be based on the fee schedule (Schedule of Values) attached hereto as Exhibit 2-A and incorporated herein, with a sum not to exceed Seven Hundred Thirty Thousand Dollars and Zero Cents (\$730,000.00). This amount includes payments for services rendered and invoices since October 1, 2022.
- 2. <u>Effective Date</u>. This Amendment shall be effective upon and after full execution by both Parties.
- 3. <u>Original Agreement</u>. Unless expressly amended herein, all other terms and provisions of the original Agreement between the Parties, including any prior amendments to the Agreement, shall be and remain in full force and effect. In the event any of the prior amendments to the Agreement conflict with this Amendment, the provisions of this Amendment shall prevail.

### ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, Alachua County (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign system. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to this Electronic Record and Signature Disclosure (ERSD), please confirm your agreement by selecting the check-box next to 'I agree to use electronic records and signatures' before clicking 'CONTINUE' within the DocuSign system.

# Getting paper copies

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after the signing session and, if you elect to create a DocuSign account, you may access the documents for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

## Withdrawing your consent

If you decide to receive notices and disclosures from us electronically, you may at any time change your mind and tell us that thereafter you want to receive required notices and disclosures only in paper format. How you must inform us of your decision to receive future notices and disclosure in paper format and withdraw your consent to receive notices and disclosures electronically is described below.

## Consequences of changing your mind

If you elect to receive required notices and disclosures only in paper format, it will slow the speed at which we can complete certain steps in transactions with you and delivering services to you because we will need first to send the required notices or disclosures to you in paper format, and then wait until we receive back from you your acknowledgment of your receipt of such paper notices or disclosures. Further, you will no longer be able to use the DocuSign system to receive required notices and consents electronically from us or to sign electronically documents from us.

# All notices and disclosures will be sent to you electronically

Unless you tell us otherwise in accordance with the procedures described herein, we will provide electronically to you through the DocuSign system all required notices, disclosures, authorizations, acknowledgements, and other documents that are required to be provided or made available to you during the course of our relationship with you. To reduce the chance of you inadvertently not receiving any notice or disclosure, we prefer to provide all of the required notices and disclosures to you by the same method and to the same address that you have given us. Thus, you can receive all the disclosures and notices electronically or in paper format through the paper mail delivery system. If you do not agree with this process, please let us know as described below. Please also see the paragraph immediately above that describes the consequences of your electing not to receive delivery of the notices and disclosures electronically from us.

To let us know of a change in your email address where we should send notices and disclosures electronically to you, you must send an email message to us at mguidry@alachuacounty.us and in the body of such request you must state: your previous email address, your new email address. We do not require any other information from you to change your email address.

If you created a DocuSign account, you may update it with your new email address through your account preferences.

# To request paper copies from Alachua County

To request delivery from us of paper copies of the notices and disclosures previously provided by us to you electronically, you must send us an email to mguidry@alachuacounty.us and in the body of such request you must state your email address, full name, mailing address, and telephone number. We will bill you for any fees at that time, if any.

# To withdraw your consent with Alachua County

To inform us that you no longer wish to receive future notices and disclosures in electronic format you may:

i. decline to sign a document from within your signing session, and on the subsequent page, select the check-box indicating you wish to withdraw your consent, or you may;

ii. send us an email to mguidry@alachuacounty.us and in the body of such request you must state your email, full name, mailing address, and telephone number. We do not need any other information from you to withdraw consent. The consequences of your withdrawing consent for online documents will be that transactions may take a longer time to process..
