## A. Approval of Agenda

#### B. Items for Discussion

1. FY25 Budget Development Deep Dive Growth Management Department - 24-00245

County Manager Lieberman and Growth Management Director Jeff Hays presented the above item.

Mr. Hays stated that the GIS Manager position he feels is needed in the County. It was a position that existed but was lost during the Great Recession. He feels the position would help coordinate GIS services across departments and benefit the County. It will be a matter for discussion during the budget development process.

Commissioner Prizzia, Commissioner Wheeler, Chair Alford, and Commissioner Cornell presented comments.

1. Public Comment

2. Commission Comment

#### Additional Dwelling Unit (ADU)

Commissioner Prizzia stated that she received an email regarding taxes on an ADU. There is apparently a tax exemption that the County can opt into but has chosen not to. She would like to look into possibly opting in as a way to encourage smaller dwelling units.

Assistant County Manager Crosby stated that if the County exempts someone from taxes the other rate payers have to absorb those cost, but it is a Board decision.

**By consensus**, the Board referred to staff to investigate how many of these properties have been permitted or qualify and determine the financial impact to the County. Report the results back to the Board by email so Commissioners can consider pursuing the option or not.
