## FIRST AMENDMENT TO AGREEMENT FOR STATE HOUSING INITIATIVES PARTNERSHIP (SHIP) HOME REPAIR PROGRAM PROVIDER AGREEMENT BETWEEN ALACHUA COUNTY AND HABITAT FOR HUMANITY, INC. NO. 13893

THIS FIRST AMENDMENT ("Amendment") is made by and between Alachua County, Florida, a political subdivision and charter county of the State of Florida, by and through its Board of County Commissioners (the "County") and Alachua Habitat for Humanity, Inc., a Florida not-for-profit corporation which is authorized to do business in the State of Florida ("Provider"), who are collectively referred to as the "Parties".

## WITNESSETH:

WHEREAS, the County and Provider previously entered into a State Housing Initiatives Partnership (SHIP) Home Repair Program Provider Agreement dated August 24, 2023, identified by No. 13893 ("Agreement") whereby the Provider agreed to administer and implement projects as set forth in the Counties adopted a Local Housing Assistance Plan (LHAP); and

WHEREAS, there was a scrivener's error in the Agreement incorrectly referencing that the funding source were from the State Housing Initiatives Partnership (SHIP) Program funds for State Fiscal Year 2023-2024; and

WHEREAS, the County desires to amend the Agreement to correctly reference State Housing Initiatives Partnership (SHIP) Program funds for State Fiscal Year 2022-2023.

NOW, THEREFORE, the County and Provider agree to amend the Agreement as follows:

- A. <u>Amendment</u>. Attachment 5, Section II, titled "Funding" in the Agreement, is hereby amended to change the referenced funding source from Alachua County SHIP State Fiscal Years 2023-2024 to Alachua County SHIP State Fiscal Years 2022-2023. All other portions of Section II remain unchanged.
- B. <u>Effective Date</u>. This Amendment shall be effective upon execution by both Parties.
- C. <u>Original Agreement</u>. Unless expressly amended herein, all other terms and provisions of the original Agreement between the Parties, including any prior amendments to the Agreement, shall be and remain in full force and effect. In the event any of the prior amendments to the Agreement conflict with this Amendment, the provisions of this Amendment shall prevail.
