

**FIRST AMENDMENT TO AGREEMENT BETWEEN ALACHUA COUNTY AND CITY OF
GAINESVILLE FOR AGE BASED FARE FREE TRANSIT PILOT
NO. 13187**

THIS FIRST AMENDMENT (“Amendment”) is made by and between Alachua County, Florida, a political subdivision and charter county of the State of Florida, by and through its Board of County Commissioners (the “County”) and City of Gainesville, Florida, a municipal corporation of the State of Florida (“City”), who are collectively referred to as the “Parties”.

WITNESSETH:

WHEREAS, the County and City previously entered into Agreement between Alachua County and City of Gainesville for Age Based Fare Free Transit Pilot dated September 28, 2021, identified as Contract No. 13187 (the “Agreement”); and

WHEREAS, the Parties have agreed to extend the term of the Agreement to allow the City to continue providing service to Alachua County; and

WHEREAS, the Parties desires to amend the Agreement to extend the term and to do as otherwise provided herein.

NOW, THEREFORE, the County and City agree to amend the Agreement as follows:

A. Amendment. Article IV, of the Agreement titled “Term of Agreement” is amended to read as follows:

The Agreement is amended to extend the term through September 30, 2023.

B. Effective Date. This Amendment shall become effective upon execution by both Parties.

C. Fixed Fee. The County shall pay to the City the total fixed-fee amount of \$115,000 during the period of October 1, 2022 through September 30, 2023 (FY23) for the age based fare free transit pilot program regardless of the number of individual trips documented by the Regional Transit System. Payments by the County to the City shall be made in equal quarterly amounts of \$28,750.00 for the period beginning October 1, 2022 through September 30, 2023 (FY23).

D. Service. The City agrees to provide bus service in accordance with the specifications of the age based fare free transit pilot program outlines in the Agreement for the period of time commencing October 1, 2022 through September 30, 2023 (FY23), regardless of the number of individual trips documented by the Regional Transit System.

E. Original Agreement. Unless expressly amended herein, all other terms and provisions of the Agreement between the Parties shall be and remain in full force and effect.
