A RESOLUTION OF THE BOARD OF COUNTY
COMMISSIONERS OF ALACHUA COUNTY,
FLORIDA, AMENDING THE FY2023-2024
ADOPTED BUDGET, ACCEPTING THE
UNANTICIPATED REVENUE FROM THE
CATASTROPHIC LOSS INSURANCE POLICY,
APROPRIATING THE FUNDS, AND
PROVIDING AN EFFECTIVE DATE.

WHEREAS, After replacement of equipment, the
Catastrophic Loss Insurance Policy has agreed to reimburse
