A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ALACHUA COUNTY, FLORIDA, TO RECOGNIZE UNANTICIPATED REVENUE FROM A DONATION FROM THE FRIENDS OF CUSCOWILLA FOR THE PURCHASE OF A LOW-ROPES COURSE AT CUSCOWILLA, PROVIDING AN EFFECTIVE DATE.

WHEREAS it is necessary to recognize unanticipated revenue for the Donation Fund (Fund 167) from the Friends of Cuscowilla to complete the desired tasks.

WHEREAS it is necessary to recognize unanticipated revenue and corresponding expenditures for the installation to be able to occur within the budget.

- 3) That this resolution shall take effect immediately upon its adoption.
