## Strategic Guide:

#### Background:

The Alachua County Housing Finance Authority (the "HFA") is a public body corporate and politic of the State of Florida, created in accordance with Chapter 159, Part IV, Florida Statutes (the "Act"). Pursuant to the Act, the Board of County Commissioners of Alachua County, Florida (the "BOCC") created the Authority by Ordinance 81-07 and now codified Chapter 32 et seq. of the Alachua County Code of Ordinances (the "Ordinance").

The HFA provides tax exempt and taxable financing for the acquisition, construction, and/or rehabilitation of multi-family rental housing projects, which satisfy the goals and requirements of the HFA, and comply with applicable federal and state law. In any given year, the ability of the HFA to provide tax-exempt financing for projects is contingent upon receipt by the HFA of an annual tax-exempt bond allocation from the Division of Bond Finance of the State of Florida (the Division). The HFA receives revenue in the form of fees from the sale of tax bonds, program participation fees

and lien payoffs from housing projects.

The HFA encourages investment by private enterprise and stimulates construction and rehabilitation of housing through use of public financing.

The mission of the HFA is to consider opportunities that increase the availability of affordable housing in Alachua County. The Authority issues tax exempt bonds for the development or acquisition and rehabilitation of multifamily rental housing complexes and loans for the development of affordable housing. Owners of such facilities are required to set aside a portion of the units for lower income persons and families.

The Alachua County Board of County Commissioners has final approval for all bond transactions. The HFA is a five (5) member board. Not less than three of the members shall be knowledgeable in one of the following fields: labor, finance, or commerce. Currently, the HFA has four vacancies: two (2) Citizen-at-Large positions and two (2) Citizen-at-Large positions (with knowledge in labor, finance or commerce).

The applications for the HFA Board are:

Duan Jones and Haley Short, none of which have ever served on the HFA and applied for Citizen-at-Large (knowledgeable in labor, finance, or commerce).

Genile Morris has applied for Citizen-at-Large (knowledgeable in labor, finance, or commerce) and has served 2 terms.

Richard Kali Blount, Allen Kurian, and Michele Lesure, none of which have ever served on the HFA, and all applied for the Citizen-at-large vacancies.

Davin Woody has applied for Citizen-at-Large and has served three terms.
