Description:

Agreement 13936 with WSB (formerly AE Engineering, Inc.), for RFP 23-403 CEI for SW 170th Street (County Road 241) Widen & Resurface - From Levy County Line to SW 143rd Avenue (LAP), in the amount not to exceed (NTE) \$368,788.47 for Public Works.

Recommended Action:

Approve and authorize the Chair to execute Agreement 13936 with WSB for RFP 23-403 CEI for SW 170th Street (County Road 241) Widen & Resurface - From Levy County Line to SW 143rd Avenue (LAP), in the amount not to exceed (NTE) \$368,788.47.

Prior Board Motions:

July 11, 2023, the Board approved the ranking and authorized staff to negotiate an agreement for RFP 23-403 CEI Services for SW 170th Street (CR 241) Widen & Resurface - From Levy County Line to SW 143rd Street. Item 23-00214

January 24, 2023 – Board approves all projects previously on the CIP, including SW 170th Street, and additional local funding to supplement FDOT grant funds. Item 23-0357

September 12, 2017 – Board approves LAP agreement with FDOT for design of the roadway resurfacing and widening and authorizes Public Works Director to execute any additional agreements related to this project. Grant funding for construction is to be made available in subsequent years.

February 23, 2016 – Board submitted safety grant application for SW 170th Street.

Fiscal Note:

In the FY24 Budget, there is \$3,906,990.64 in currently available funds in the FDOT Grants Fund in account: 329.79.7910.541.63.99 project 9177912. The account description for the account is Other Infrastructure.

Infrastructure

Background:

The SW 170th Street project was programmed to reduce the potential of sideswipe crashes and lane departure crashes. FDOT requires the County to deliver the project via Local Agency Program (LAP).

In April 2020, the Public Works Director executed a LAP agreement with FDOT for the funding of construction and CEI services for the widening and resurfacing of SW 170th Street from the Levy County line to south of the City of Archer, as authorized by previous Board action (see above). Construction is to be completed in FY 25.

RFP 23-403-TW CEI Services for SW 170th Street (CR 241) Widen & Resurface - From Levy County Line to SW 143rd Avenue - LAP was released on January 18, 2023. The deadline for receipt for RFP 23-403-TW CEI Services for SW 170th Street (CR 241) Widen & Resurface - From Levy County Line to SW 143rd Avenue - LAP was March 1, 2023, five (5) vendors responded.
